Sokoto to fight sand-dunes with

he Sokoto State Gov-

ernment has requested for a federal assistance of N150 million to tackle a "turbulent and destructive" desert sand-dune which is threatening to take over some villages in the state.

In a memo it despatched to the Federal Government through the Federal Ministry of Environment, the state government says "the state is handicapped and could not handle this gigantic but very vital project and, therefore, requires immediate federal government intervention."

The memo stated that if the request is approved, it will establish a 100 km shelterbelt, woodlots and orchards, block plantation and grassing as well as the establish a 1 million seedling capacity nursery as part of efforts towards arresting the effects of the sand-dunes.

It cited the case of Gidan Gado village as a pathetic example of a village about to be enveloped by sand-dunes if nothing urgent is done to stop the menace from getting out of hand.

The News Agency of Nigeria (NAN) which obtained a copy of the memo reports that "Gidan Gado is a village north-west of Gidan Kaura in Gada Local Government Area of Sokoto State.'

According to the state government, the village is being "devastated by sanddunes just like it happened in Gidan Kaura.

It added that the "the life of people in that village and of course other surrounding villages is miserable and threatened by turbulent and destructive sand that moves periodically and miraculously southward, eastward and westward.

"Houses are being engulfed and endangered by the moving sand exactly as it happened in Gidan Kaura which led to its eventual resettlement."

It further explain that sand-dunes from the extreme Sahel zone of the Sahara were observed to have settled in those villages due to what it described as "strong barrier of mountainous landscape that characterised the environment."

The state government recalled that the Gidan Kaura experience "was a clear testimony of how destructive and damaging sand-dunes could be," adding that over 70 percent of farmlands were devastated by sand-dunes at the Gidan Kaura village.

Apart from houses that were engulfed, roads were hardly identifiable, dug wells filled up with sand while livestocks were destroyed, it states.



It was at this stage that luck ran out of the fake ACG. when Mothercat contacted the Immigration headquarters in Kaduna to verify his claim.

The Immigration Department immediately contacted **ETOS and Ideal Flour Mills** to let them know of the developments and sought their cooperation to help arrest the man.

Meanwhile, Umar Hussaini was not aware of what was happening underground until he appeared at Ideal Floor Mills, where sensed something fishy and escaped under the surveil lance of the company curity men, who were in structed to keep watchful cyes on him.

Unfortunately for him ria where he was arrested by some Immigration officers detailed by the state command to effect his arrest.

After the arrest, Umar Hussaini, in his statement to the police, confirmed that he was not an Immigration officer let alone being an Assistant Controller General

He also confessed that he produced the call cards and office jotter all by himself.

When contacted, the Chief Controller of Immigration in charge of Kaduna Command, Alhaji Mohammed Babangida Beli, confirmed the incident and directed this reporter to the state police command for details.

The Kaduna State Commissioner of Police, Alhaji Mohammed Shehu, told Daily Trust that the police is making further investigation on the matter after which Umar Hussaini will be charged to court.

It would be recalled that about two months ago the Kaduna Immigration Command arrested a money doubler and handed him over to the police for further investigation and conviction.

Up till the time of filing this report no traces have been tound of which court the case was referred to.

FG to stem industrial pollution in Kaduna

onsumers of food crops grown along the banks of Kaduna river and residents of the metropolis, may no longer worry about industrial pollutants as measures would soon be adopted to mitigate the impact of pollutants, the Minister of Environment, Alhaji Muhammad Sa'id, said in Abuja yesterday.

Muhammad said at a consultative meeting with representatives of major industrial establishments in Kaduna State that a CIWAT consultant, Engineering Ltd., had been appointed to study the problem of industrial effluent in the state.

Consumption of food grown along items contaminated water bodies, or fish products from contaminated water, could lead to cancer, typhoid and cholera among other health problems.

like crabs and fishes which live and feed in contaminated waters have the ability to chlorine-based ingest contaminants which they can transmit to man along the food-chain.

He lamented that previous efforts by government to stop the "continuous and flagrant discharge of untreated effluents" into the environment had not yielded the desired results. "As a responsible government, conscious of the environmental disasters posed by industrialisation, the first legitimate action would have been to close down all factories until effluents are treated to legally satisfactory levels," he noted



Association blames ministry on failure of agriculture **ll** Farmers Apex

Association of Nigeria (ALFAAN), Kano State chapter, has blamed the Federal Ministry of Agriculture and other agricultural institutions for exhibiting nonchalant attitude toward agriculture in the country.

In a statement signed by the Secretary to the association, Alhaji Ali Madigawa, and made available to the News Agency of Nigeria (NAN) in Kano at the weekend, the association expressed dismay that despite the N5 billion budgeted for agriculture this year, there was nothing to show for it.

The association recalled that President Olusegun Obasanjo had during his political campaign, promised farmers the necessary support and that he would ensure that subsidy on agricultural inputs were increased.

Customers owe NEPA N2bn in Kano zone – GM

ational Electric Power Authority (NEPA) customers in Kano, Katsina and

Jigawa States are owing the authority more than N2 billion, the General Manager in charge of the Kano zone, Alhaji Ishaq Usman, has said.

Usman told the News Agency of Nigeria (NAN) in Kano at the weekend that the customers included government agencies, private organizations and individuals. However, the authority generated N1.5 billion as revenue last year, he stated.

present administration in providing adequate and uninterrupted power, through a renewed commitment to duty and prompt attention to customers' complaints.


BASEPA begins pilot scheme on desert control

he Bauchi State Environmental Protection Agency (BASEPA), has embarked on a pilot scheme of desert control in all the 20 local government areas of the state in an effort to check desert encroachment.

BASEPA's Director of Conservation, Mallam Nasir Shehu, told the News Agency of Nigeria (NAN) in Bauchi yesterday, that the agency has earmarked some hectres of land, where both economic and noneconomic trees would be planted. Shehu explained that the

scheme would provide firewood for villagers and help to stabilise the environment, with a view to increasing the area's micro climate in the long run.

He said the agency, in collaboration with the state government, had commenced dredging of River Sakwa in Gamawa Local Government of the state to cut an ox-bow lake formed by the river which could cause flooding if left unchecked.





DAILY TRUST EDITORIAL At the mercy of robbers

igerians have come to a gradual realisation that their country is not safe. Rich and poor, they have watched helplessly as people of the same status are brutalised, maimed or killed in armed robbery attacks.

One incident which introduces another dimension to this state of insecurity is the attack last week on a group of doctors from the United States of America who were in the country to give medical care to the poor in Oyo State. The incident occurred a few kilometres outside the Murtala Mohammed International Airport as the visitors were being conveyed to their destination on arrival. The doctors were not hurt, but their Nigerian driver sadly lost his life and the visitors, in fear, beat a hasty retreat and returned home on the very flight that brought them.

The incident once again, is a reminder to the Nigeria Police Force and indeed the federal government that more needs be done to make lives and property safe in this country. Police reports regularly show continued increase in the level of crime, particularly in Lagos State where recent statistics reveal that in the first half of this year alone, about 236 persons lost their lives in armed robbery attacks. Figures from other states may only be slightly better.

The federal government's efforts to attract foreign investors to Nigeria, which our economy so badly needs, can only receive a negative boost given this state of all-pervading insecurity. No genuine investor will heed the call to invest where the safety of his investment cannot be guaranteed. The situation also portends doom for the nation's tourism industry which is presently in desperate need of foreign patronage.

It is disheartening that successive administrations have all apparently failed to halt crime on our streets, and the situation has led many to conclude that robberies and the attendant loss of lives have become worse in the present democratic era.

We believe the battle with men of the underworld has not been lost yet. Governments in all the three tiers have the capacity to reduce to the barest minimum or even put a stop to the wanton activities of robbers if crime prevention efforts are redoubled. As has been said many a time, the training and retraining of members of the police force is vital in the war against armed robbers. The provision of modern and sophisticated crime fighting equipment will also help and perhaps fewer will be tempted to crime if they could make a living in an improved economy. We also urge the government to pursue a vigorous orientation programme to sensitise Nige rians on the need to be committed to the effort to rid our society of miscreants. The war against them must be a collective one, one which All Nigerians must feel they have a stake in and a part to play. The Nigeria Police Force, on its part must put measures in place to ensure that it cleanses itself of 'bad eggs' who connive with robbers to perpetrate nefarious activities. Our nascent democracy may be threatened by the recklessness of these armed robbers. We believe the government knows very well that an electorate that does not feel a sense of security in a country is quick to withdraw the confidence it has in its leaders



TUESDAY COLUMN Women and agenda 2003

Recently, Plateau hotel played host to an impressive gathering of men and women from all walks of life, politicians, civil society activists, civil servants and professionals.

They were drawn from the 19 northern states to participate in a training of trainers' workshop. It was organised by the Community Partners for development CPD, a Lagos-based non-governmental organisation and sponsored by the United States Agency for International Development's Office of Transition Initiatives us AID/OTI. The workshop was one of several organised in different parts of the country under the democratic development initiative funded by USAID/OTI named Agenda 2003 and facilitated by CPD.

In her introductory remarks, the National Coordinator of CPD, Barrister Ime Essien Udom told participants that Agenda 2003 is a three-year political process "that seeks to stimulate the building of partnerships and coalitions between potential women politicians and change agents, strengthen their capacity to make a difference, position them properly to act as democracy watchers, and eventually produce an impressive corps of women politicians who will contest and win elections in the next Nigerian democratic government". Agenda 2003 has the following objectives, building partnerships between women and other change agents for a more equitable democratic experience, increasing women's political participation by the year 2003 and improving the quality of politics in Nigeria. Others are, negotiating and monitoring the implementation of the Affirmative Action, supporting women candidates to vie for political office and encouraging women's constituencies to be more responsive and proactive to the development of Nigeria's democratic process.

To achieve these objectives, Agenda 2003 has planned various activities between January and December 2001. They are voter's education, capacity building for Democracy Watch platforms in the six geopolitical zones, training of legislative interns for gender watch in the legislatures and intensive training for women politicians and media practitioners in order to enhance the image of women politicians. Other activities such expectations of men and women, in their various cultural milieus. The outcome of the group work confirmed the classical gender differences already documented in many cultures.

In the social sector, the man is seen as the head of the household and breadwinner who goes out to earn an income for the family's maintenance while the woman is seen as the nurturer of children, cook and care giver. In the political domain, the men are the key decision makers at national and other levels while the women are involved at local level in activities linked to their domestic roles. They are the singers and dancers who welcome delegations, providers of hospitality, community mobilisers and voters.

In the educational sector, differences abound in the opportunities given to boy and girl children.

Boys are often the beneficiaries of the best education because family resources are directed to them while girls are denied education or encouraged to take less challenging academic tracks or careers. In the economic sector, the men have access to financial and productive resources such as loans, credit schemes, land and lucrative careers.

The concepts sex and gender were then defined by the participants. Sex refers to biological differences between women and men which are God given, permanent and universal while gender refers to the social roles and responsibilities of men and women in a particular culture or location. Because gender roles are created by human beings, they do change and are influenced by many factors such as religion, class, economic power, individual and institutional bias.

Other topics discussed under the gender segment were advocacy, mobilisation and establishment of a gender watch, which is platform for monitoring the implementation of gender equity in policies and programmes. The next session on working with the media was facilitated by ace NTA newscaster Mrs. Bimbo Oloyede who is now a media consultant. She elicited from participants their knowledge of the media, and examination of their target audience. The session focused on using the media for political campaigns. The various methods for maximizing the use of the media were also identified which include imaginative and creative advertisements, use of alternative media and other affordable methods.

as voters' education, political skills training, developing political manifestoes and mobilization activities are also scheduled to take place in the year 2002.

The Jos workshop had four sessions. The first session on transparency and accountability was facilitated by Major General Ishola Williams, the secretary-general of Transparency In Nigeria, TIN. Adopting a participatory approach, he elicited from participants their understanding of the concepts politics, power, empowerment and civic responsibilities of a citizen. In discussing transparency and accountability, the need to monitor leaders and to ensure that leaders report back to the people who elected them was underscored. To promote transparency in the process of governance, leaders must be willing to open, their accounts to the public and also encourage the electorate to form its own monitoring group.

The session on Gender facilitated by my humble self-focused on defining gender and how to ensure gender equity in all activities, projects and development plans. Participants were divided into two groups where they listed the roles and Other strategies that an aspirant or candidate must explore in organising an effective campaign were listed. They include being good sales people by reaching out to friends family members, constituency audience and the general public. The candidate must be made newsworthy, should capture and sustain media attention and use media contacts. Under Agenda 2003, the woman aspirant must be a person with integrity who is acceptable to the people and has a dynamic plan.

Participants were then divided into three groups for group work in which they were asked to draw up a profile of their ideal woman candidate for the post of a local government chairperson. The fourth session was on the constitution. Titled: 'Know your constitution', it was facilitated by Dr.Timiebi Koripamo-Agary .It discussed human rights, democracy and the electoral process while the last session was on conflict management and consensus building.

Hypocrisy in mediocrity

ne of the vices detested by God in all its manifestations is hypocrisy. As a reminder, all the major world religions, Islam, Christianity, Judaism and others have condemned this societal anathema vehemently in their scriptures. Painfully however, our society is gradually being infested by this monstrous behavioural pandemic which is threatening to destroy the mainstream values of our coexistence.

Endeavour to examine your environment closely; I mean your home or living environment, your office or working environment, your interpersonal or group relationship, and to a large extent, your community and the entire nation. If you do, you will confirm that not all that glitters is gold; that hypocrisy, indeed, thrives in mediocrity.

Mothers with such a habit should know that the future of their pet is in danger, as he/she would be hated, detested and even ostracised by contemporaries.

A polygamous family is another good example. The most favoured wife is the one who dances to the whims and caprices of her husband. She reassures him constantly of his wisdom and good sense of judgement even though the man is clearly a coward and incompetent in running his home. This singular flaw in a husband can breed hatred, jealousy, ill feeling, malice, rancour, treachery and disunity among the family members, as those aggrieved would like to react viciously. In the end, the man of the house would be at the receiving end of the crises.

A peculiar type of hypocrisy exists at public gatherings, offices and working environment and in our entire national life. It is a more politically oriented type of hypocrisy. It is disheartening to note that, out of fear of complexes, hypocrites tend to relegate and frustrate the progressive forces in a rat race that is apparently geared towards actualising or maintaining undeserved political ambition. To this end, whenever the progressive distinguish themselves or do things that require commendation or recommendation, what they get in return is condemnation. This is unfortunate but time will always vindicate the just.

The hypocrite relies heavily on eye-service, misinformation and disinformation of the appropriate quarters on the conduct of their colleagues. What a vain struggle for undeserved political ambition.

It is often said that the guilty are always afraid and that those who are wicked always run even when nothing pursues them. The hypocrite, in his or her characteristic but false show of benevolence and innocence, exudes a lot of outward simplicity and virtue, but deep in the heart, a sinister feeling of ill will abounds.

CIL's misfe and By Aliu S. Sadiq

ince February 9th when the licence of Communication Investment Limited (CIL), the only indigenous communication company that successfully scaled the initial hurdles in the bid for the acquisition of Global System Communication (GSM) licence was revoked, much has been said and written either in condemnation of the Nigerian Communication Commission (NCC) or in sympathy for CIL. We know this much, but our conscience and soul leave us with no alternative than to rant and such rants whether anybody likes it or not, are the echoes of Nigerians with high spirit of patriotism and concern for anything Nigeria.

This piece is not intended to whip up sentiment or arouse sympathy for CIL, but if along the line of our argument, people become emotionally attached and begin to sing the song of solidarity for CIL, we cannot help it but to join in the Makossa dance. If we fail to achieve our desire, then it becomes a dirge for CIL.

We can only understand and appreciate the true picture of the whole story of GSM and CIL if we can cast our mind back to the early days of this present administration.

At the beginning, President Olusegun Obasanjo promised to break the monopoly enjoyed by NITEL in the telecommunication industry by revolutionising the industry. He made good his promise early this year when he set up necessary machinery to introduce GSM.

The auction of GSM licences was initiated with the NCC as the umpire and CIL was one of the four companies with evident financial backbone which earned the licences. It was the only wholly indigenous company to make the exclusive league. South Africans own MTN and Econet the other two successful companies. The fourth company was NITEL, which simply benefited from federal government decision to reserve a licence for it.

The law required each of the successful companies to pay a non-refundable deposit of \$20 million. They were also expected to pay up the balance of \$264,850,000 fee to NCC through the Central Bank of Nigeria on or before February 9, 2001. This was the beginning of the waterloo for CIL in the bid to launch itself to the world through the GSM.

While NITEL, MTN and Econet met the requirements, CIL could not. Its financiers, Paribas Bank of Paris discovered

that the frequency allocated to CIL was a subject of litigation between the federal government and Motophone, one of the 14 companies granted GSM licences in 1998.

The bank asked for a guarantee that the interests of its client would not be affected by the litigation and the NCC considered this "conditional" payment a breach of the auction laws and therefore rejected it. It immediately applied the penalty provided under article 4.7.11 and withdrew the provisional licence issued to CIL.

This action by NCC to revoke the license earlier granted ignited public outcry

A few days ago, CIL sought to remind Nigerians of its outstanding case by taking up newspaper pages to argue that the decision to revoke the licence to it was illegal and unjust. Ever since the licence was revoked, CIL has been begging and explaining its own side of the story to Nigerians.

What is more worrisome is that CIL is the only wholly indigenous company among the competitors. Apart from launching the name of the country in the international market, the company would have served as another avenue to assess our level of performance in telecommunication development.

The argument of strict adherence to the rule of the game put forward by the NCC is not tenable at all. The issue is more of prejudice than sentiment. We always want to claim that we copy America in everything we do. But Americans always put American interest first before any other. The argument by Ernest Ndukwe of NCC that GSM is a global system is therefore rubbish and unpatriotic. If the communication business is global, does that mean we should sabotage our local companies so that foreigners can continue to make billions of naira at our expense. It is rather unfortunate that we still have plenty Mr. Johnsons in our midst's who, perhaps, have all been promised appointments as directors. while million of others will be mere labourers.

The bitter lesson one can learn from this is that the reward of patriotism in the Nigerian context is frustration, and victimisation.

In conclusion, I strongly appeal to the government to at least bend the rule to refund part of the whopping nonrefundable registration fee paid by CIL. By doing this, CIL's hope will be rekindled and the spirit of patriotism will continue to be enlivened.

If America could go to this length against its allies, what stops Nigeria that is still 'sleeping' to at least stir and this trend of nonchalance continues, the options left for local manufacturers are either to close shop or move to favourable environments in neighbouring countries. The obvious consequence is that of further unemployment in a country where unemployment is already endemic. Since the government cannot employ everybody, it is only fair to create an enabling environment for the private sector to at least survive.

Adams denies MIreland minister's peace claims

inn Fein president Gerry Adams has rejected claims by Northern Ireland minister John Reid that a peace deal is "tantalisingly close

Mr Adams also appeared to rule out decommissioning by the Provisional IRA within the next six weeks.

His comments followed the restoration of devolved government to Northern Ireland, which came after a 24hour suspension in, an attempt to give parties more time to agree to a peace package.

"Behind the soft words really what is being opened up is a six- or seven-week period in which the British Government and unionists are going to try to put pressure on republicans to move to resolve issues on British Government or unionist terms," he said.

Mr Adams was speaking at a rally to mark the 20th anniversary of hunger strikes by republican prisoners.

He said: "I hear a British Government that says a deal is almost within reach," he said.

"Does this mean they're going to pull troops from south Armagh, from south Tyrone, west and north Belfast?

"I hear also the patronising tone that the institutions have been stood down for only one day and now it's OK again. Well, it's not OK again.

Mr Adams' words followed a warning from party colleague Martin McGuinness that the IRA's recent offer to put its weapons beyond use may have been jeopardised by the suspension, and by unionist rejection of the offer.

The plan - to put its weapons permanently and verifiably beyond use - had been accepted by General John de Chastelain's international decommissioning body.

But Mr McGuinness said suspension had seriously damaged his community's confidence in the institutions and could now have implications for the IRA's plan.

There have been reports of

best hope for peace in Macedonia. The leaders should take this opportunity and sign the document," he said.

But diplomats say it has little chance of ending a sixmonth insurgency by the ethnic Albanian rebels, unless hostilities cease.

Nato is due to send in 3,500 troops to disarm the ethnic Albanian rebels, but it is unclear where Operation Essential Harvest would begin if fighting

were to continue.

BBC correspondent in Skopje says events on the ground appear to be moving towards a sustained conflict, with the government's military response becoming increasingly robust in the battle for territory.

"The most realistic thing ... is to undertake a very strong offensive to destroy the terrorists," said Interior Minister Ljube Boskovski.

The main road from Skopje to Macedonia's second city Tetovo has been closed by the authorities, and there were reports of more fighting near the northern border with Kosovo on Sunday.

ODD WORLD American double amputee climbs Everest

n American mountaineer who lost both his lower legs in a flying accident is attempting to become the first double amputee to climb Mount Everest.

Ed Hommer, a 45-year-old pilot from Duluth, Minnesota, who arrived in Kathmandu Sunday, plans to tackle the 29,035-foot mountain from the Tibetan side with a seven-member team.

The expedition, led by Jim Wickwire from Seattle, expects to arrive at their base camp on August 20 for the assault on the North Face of the world's highest mountain.

They hope to reach the top in the first week of October. "I have been climbing since 1975. Just because I'm a double amputee, I shouldn't stop. You do the best of your abilities," Hommer told Reuters.

Hommer lost both his lower legs after a light plane he was piloting crashed over Mount McKinley in Alaska in 1981.

His legs became frostbitten after he was stranded on the mountain for several days, and had to be amputated several inches above the ankle.

"I think my climb can be an example to other amputees about what we can do," he said.

The fist amputee to climb Everest was Tom Whittaker, who lost his right foot in a car accident. He reached the summit in 1998

When that time comes America would then be able to play the role of an unbiased and objective arbiter in the conflict. It is then that the Americans would have the moral courage to tell the Jews to move out of the occupied lands and Golan Heights without delay. Infact it would indeed be in the interest of Jews to do just that because then and only then could they stop running Israel like a garrison state. Only then will the state of Israel enjoy true peace - the kind it has never known or enjoyed since it was created.





dramatically by 89 percent, from N22.341 million (or N22.34 billion) in 1999 to N42,130 million (or N42.13 billion) this year (2000). This is as a result of increased aggressiveness in deposit drive adopted during the year," the BONL chairman affirmed.

Lugga stated further that "as an indication and guarantee of continuous growth and expansion, the bank's balance sheet size in terms of Total Assets rose by 60 percent form N32,264 million (or 32.26 billion) in 1999 to N51,548 million (or N51.54 billion) in the year 2000.

Though the bank did not declare any dividend to be shared to its shareholders out of the profit recorded, the bank's shareholders' funds increased by N1,200 million

(or N1.97 billion) achieved at the end of 1999.

Meanwlile, the board of Directors of Bank of the North Limited has raised the banks paid-up share capital to N1,200 million (or N1.2 billion), with the transfer of N600 million to its bonus issue reserve, while that bank's authorised capital was accordingly raised to N1,500 million (or 1.5 billion).

The bank, which for the first time held its annual general meeting outside its headquarters in Kano and away from the country's federal capital city of Abuja, also commissioned two new offices in Maiduguri. The offices are its regional office located along Bama Road and its Maiduguri Monday Market branch, both of which were commissioned by the Borno State Governor, Alhaji Mala Kachallah, ahead of the AGM.



Flourishing Rose flowers

Stockholm is the capital of Sweden, and it possesses so many charming sce Mid-summer celebration is a marvellous experience. Y.Z. Yau was in Swede

Town hall or Sodorkoping, constructed in 1977 oming from Nigeria, where changes in weather do not have any cultural significance, summer has only one meaning for me in this part of the world: the temperature would be more tolerable. There is of course the trouble of having to go to bed in the night when the sun is still shinning. So when Dr. Gunilla Andrea, my co-host in Stockholm suggest that we go for a mid Summer holiday, I thought she was carrying her love for summer too far. Somehow, however, on Thursday when I went to Statsvetensk (that is how they refer to the Department of Political Science at the Stockholm University. Statsvetensk in Swedish means Science of the State), and everyone at the coffee room was talking about the

holiday. By this time, however, one had come to learn that the day was going to be a public holiday. This I learnt because we the celebration, which for many

involved a trip to the countryside or some other scenic spots. For this year, midsummer was celebrated on June 16th, a few days to the actual solstice, which was June 21st.

On that Thursday, both Bjorn and myself closed early from the office so that we could join Gunilla for dinner after which we could concretize the plan for the midsummer holiday. The Swedes love holidays, but love summer even better, especially when the summer is not too rainy. This year's summer was all-bright, the heat quite right at the average of 17 degrees centigrade. The rain was isolated and not too heavy. Sunlight was about 20 hours a day, starting from about 3 a.m.

A report of a possible rain forecast against Friday altered our plan and I was happy it did. Essentially, what we agreed was that we could spend the Friday in Stockholm to attend the Maypole celebration and then hit the way to Gunilla's country house on Saturday morning on Friday evening, Dr. Ebrima Sall was to join us from Uppsala. In the evening he phoned to say he could not make it because he was just coming back from a journey and was rather tied up with other engagements. We were going to spend the afternoon at Skansens, a different island from the Sodermalm Island where I was staying. We had to take a bus from Ljusterogatan which was the street where I lived) to Slussen from where we joined the boat to the other island. This island is actually opposite Sodermalm, with the water that is dividing them forming an inlet through which one could go to Finland By the time we arrived at

the Slussen anchorage we met long queues of people waiting to board the ship. We thought we might not make it but somehow the organizers have made adequate arrangement with a number of ships making the trip at a time. The event is annually coordinated by the Swedish Foundation for Culture, which is also responsible for management of the venue.

Now Skansens is a mixture of both tradition and modernity. It is one huge amusement park that occupies a large part of the Jyusdegatan Island. The amusement park is divided into two. The first part, adjoining the sea facing Sodermalm is the very epitome of modern recreation. The inner part is an expanse of forest that is taken by a number of projects. There are many shops and small-scale factories for handcrafts such as glassware, furniture and other cultural artefacts. There is a huge concert hall. There is the open space for picnickers and

mass of people who had come out for the event. It was as if everyone in Stockholm, if not in Sweden was out at this place. Sweden has a population of about eight million of which close to two million live in Stockholm and its archipelago. The situation is only comparable to a sallah day in Kano, at the time of returning from the eid prayer. And they were dressed in costumes depicting the different parts of Sweden. These costumes are colourful. But one common thing was the flower ring on the head. Almost every woman, girl and boy had such beautiful flowers. Children in child-carriages were also decorated with flowers.

Curiously, the men did not have flowers and I did not find out why, or did I? Sweden boasts of strong gender equality. The current national government has a council of ministers of 20 with equal representation from both sexes. There is a law for equal opportunities and there is even paternity leave. The first time Nelly, from the Department of Political Science, who had delivered before my arrival, told me that it was the turn of her husband to be on paternity leave, I thought it was an informal arrangement. I discover that a father is entitled to three weeks paternity leave. But in this flower business I did not see gender equality!

European neighbours. But there is actually more to the flowers than just a matter of a national symbol. It took us several minutes to decide if it was worth joining the queues for the ticket or to catch the ship back to Slussen. The problem was that we had aimed to stay for three hours so that we could be back home in time for midsummer dinner. If we had to spend one of these three hours on the ticket queue, we would lose a lot of time. Anyway we decided to stay and eventually got our tickets and joined the shorter queue for the entrances. Here I must note the efficient way in which the queues were attended to, which made it appear much shorter than we had seen

We made our way up the hill through a winding path. The main event was taking place at the summit of the hill, where it was flat. Immediately we scaled the height, Bjorn drew my attention to a single tall pole-like flower. We were of course far so at this stage I could not relate it with the mass of people pressing around it. He said it was the Maypole. Now I thought Maypole was the name of that particular flower. After all one is very poor in knowing the names of flowers or even other plants. I guess that was what scared me from the study Botany. This Maypole, I found is not just a flower. It was really a very tall constructed stick structure around which leaves and flow ers of all colours were wrapped. I asked why the structure is called Maypole and not Junepole given that midsummer is June. We agreed that we would find out. The Swedish name for it is actually midsummer pole. At home, Laura, the

Beckmans' daughter, fresh from her examination, decided to look at the encyclopedia of European ceremonies to tell us why the name is Maypole. It turned out that Midsummer was actually a European wide tradition usually celebrated on May 1. Somehow across Europe, where the tradition has survived, the date of celebration has shifted from the beginning of summer to midsummer but the name of the pole has retained its origin, at least in the English language.

You must be wondering what this Maypole has got to do with the celebration. The fact is that it is so central to the occasion. By the time we reached the place, it was a huge system of concentric circles with the Maypole as its centre. At one tip of the outer circle was a raised platform with the Swedish national flag flying. A canopy shaded the platform. In the shade were a group of musicians dressed in white and red costumes. They actually looked like sisters in the church or female nurses in hospital. But they were folk drummers and singers.

By the time we arrived, the announcer over the public address system was asking those who were not dancing to step out of the circles but no one really moved out. It was so jammed with old men, people in wheel chairs, children in carriages and young adults both men and women. Having made her point, the announcer let it be known that it was time to dance. All of a sudden the folk musicians started singing and drumming. The thick crowd soon picked up the tunes and sang in unison. In the meantime, everyone who could find space for his/ her feet was dancing. We danced left and right, forward and backward, up and down.

needed to get to the Immigration office and Prof. Bjorn Beckman, my other co-host, had said that we had better do that on Thursday or else it would have to wait till Monday. When I asked him why we could not go on Friday, he, with an astonshed look on his face, educated me that Friday was midsummer Day eve and midsummer is a national holiday.

Midsummer celebration is an old practice in Sweden. The actual midsummer is supposed to coincide with the summer Solstice, which is the longest day. But in modern times, the Swedes celebrate this occasion on the Saturday nearest to the actual Solstice day. The Friday before the celebration is then observed as a national holiday to enable people to prepare for

open air events, and then there is the zoo, so natural in the forest that you think the animals were actually there and the fences were the only thing added. This in a way is true, because it was converted into a public space, animals inhabited it.

In addition to these is the dwelling exhibition. This is a collection of a prototype of houses from different parts of Sweden. They were actually brought down from their native locations. There were also various granaries and animal housing. Backgrouded by rising hills and sloping valleys, all these give you a rich panorama of architectural Sweden.

When we arrived at this part of the park, even Bjorn and Gunilla were shocked by the

By the time we came back, the streets were empty and all shops closed except for the migrant shops that were making brisk business. At the Beckmans' we had a spe-Acial traditional midsummer dinner, eaten with the etiquette of the occasion. Even the drinking of water was timed and the food was accompanied with folk songs. The Swedes love singing and I asked Gunilla whether there were professional singers in Sweden, my reason being that they would not sell since virtually everyone could sing!

Talking about food, I never got to know the names of the various Swedish dishes that my host treated me so generously to. I recall the first time I ate in a restaurant; Bjorn had to explain the dishes for me to make my choice. At the university restaurant they usually have sample plates of all the dishes of the day by the counter, so one just indicates the plate containing his choice.

The Swedes eat a lot of vegetables and green with a taste for sugar and less of solid food. The latter was to be a source of protest by Sylvester Odion. We had eaten lunch provided by the International IDEA during its conference on Democracy and Information Technology at the Stockholm Conference Centre. The meal consisted of two pieces of potato and salad. Odion had asked whether the main course was coming but after a while we left with only tea coming. Potato was the main course. When we met Babatope Babaiide of

Nigeriassemblyonline, he complained about the lightness of the food. I mentioned this to Bjorn, who kindly agreed to host this Nigerian crowd to a dinner in his house where we ate a lot of rice to compensate for the previous meals.

So much for Maypole, it was time to take to the sun and watch the flowers bloom in the countryside. Setting off for Gunilla's country home, was itself not uneventful. Gunilla had left very early to the office, from where she was to catch the bus

it earlier. We joined the bus but it could not move. Soon the driver came round, talking to people. Bjorn did the translation: there was an unusual flow of passengers and since getting connection is timed, everyone wanted to join the bus. But the drivers had instructed that they could not take an overload of up to eight people (without luggage) and five (with luggage), otherwise if the driver is caught, he loses his/her driving license. The orderly passengers soon obliged and we got going.

However, because of this little complication, we could not arrive at the right time and all the connecting buses for those of us going out of Norrtalje had left. This meant we would have to wait for 20 more minutes to get into the next bus. For those of us who were going to Grisslehamn way, the driver decided to pursue our connecting bus, an unusual option, since he was going to create another problem for those going to Stockholm, where he was to return. For more than 10 minutes he could not establish contact with the bus and most of the passengers were cursing privatization as the cause of the problem.

Until recently, the transport system in the Stockholm region has been run by the government. However, the ruling Liberal government had introduced some limited privatisation, which allows private companies' to run the bus system on more or less commission basis. For a Nigerian, where public or private, the buses are crowded, untimed and arbitrary, the delay seemed quite amusing. I still could not understand where the fault of privatization lies in this particular instance.


Going up north from Stock holm one is struck by the variegated landscape of Sweden First, we left the waters of Stockholm. Immediately after Taby one gets a fine view of well-maintained forest. Going further up, the land begins to appear rocky. This supports little agriculture and indeed proceeding up north where what is called the Lappland, no agriculture takes place. It is incredible that only eight percent of the total land of Sweden is under cultivation with only 2. percent of the labour in agri culture, yet the country is selfsufficient in food production.

We got to Ortp at about p.m. and crossed a stripe bridge, which separates the in land we were going from the main Stockholm Island. This is yet another thing about Stock holm. It is officially referred to as the city on an island. Truly Stockholm is a city in water The city, which consists, of over 1000 islands, is actually on the inlet of the Baltic Sea.

A few kilometres from here we were at our place. This is a very remote rural setting, much like the Fulani settlements in the plains of Hadejia-Jama'are River basin. The Andrea home consists of two main houses and three other smaller ones One of the big ones is the Gunilla's while the other is her brother's. Up the road, their neighbour is about half a kilometre away while further in, the next neighbour is about a kilometre. Facing the house for about one kilometre is a thick forest, which ends up in the sea.

We settled into our new houses and had tea and later rested. I was shown to the con veniences, including the latrine as Bjorn calls it Later we decided to take a walk through the forest to the sea.


NAFDAC destroys N83m worth of drugs

The family first aid kit include the following herbs - Anise, Garlic, Lemon, Honey, Onion, thyme, Rosemary, Cayenne (red pepper), Ginger, Cinnamon, Basil, Cloves, Fenugreek, Nutmeg, Aloe Veral Gel, Swedish Bitters (if affordable). also in the kitchen most of the preparations are carried out using boiling water and common utensils (bowls cups and weighing scales).

Clove is one such herb it has antiseptic and anti parasitic properties it a digestive aid, warms the body, promotes circulation, and it is used to treat yatolence, vomiting, and nausea. the oil of it is used to relieve tooth ache or chew 1-3 seeds of cloves and place around the aching tooth.

N.B Clove oil should be used with care because of irritation but can be diluted with olive oil or distilled water. Suitable as mouth wash.

Celery, reduces blood pressure. It is an Appetitestimulant, suitable in arthritis and kidney problems. Acts as antioxidant and as a sedative.

N.B. Do not use large amounts in pregnancy.

Corn silk aids bladder, kidneys and small intestine. Suitable diuretic. good for enuresis (bedwetting), oedenot, obesity, pre-menstrual syndrome. When combined with kidney herbs, opens the urinary tract and expels mucus from the urine.

Fennel is a very valuable seed spice and appetite suppressant, eye wash, promotes kidney, liver spleen and functions, clears mucus from lungs, relieves abdominal pain, gas and g.i.t. disorders. (Use: one teaspoonful of crushed seeds to a cup of boiled water and steep for 10–15 minutes) 2 x daily

Fenugreek is a Good laxative, lubricant, reduces fever, good for eyes, helps asthmatic people and sinusitis by reducing mucus. good for inflammation and lung disorders. Useful in ulcer patient, treatment of diabetes and gout. Aphrodisiac and a rejuvenator.

he police in Lagos have arrested a youth corper who served in. Jigawa State suspected to have master minded a bank robbery at Union bank, llupeju, Lagos were about N13.7 million was allegedly carted away.

Briefing newsmen in Lagos, Mr. Mike Okiro, Lagos Police Commissioner said a member of the gang of seven armed robbers that robbed Wema Bank Plc, Okokomaiko branch, Ojo, on June 7, 2001, Kingsley Okire was arrested and in the process of interrogation also confessed to the Union bank robbery which Paul Samuel Chime the youth corper master minded.

The armed robbery suspect also confessed robbing Atlantic Textile Manufacturing Company Limited, Rose Pure Water and a bakery at Igbosere in Lagos.

Other places robbed by the gang included A.A. International School and Boutique Fashion House in Satellite town.

According to Mike Okiro, effort is being made to arrest other members of the gang still at large in order to recover the robbed money and property as well as their guns.

Other members of the gang include Rashidi Abu 24, Sunday Akaka 23, Alex Nagberi 23 and Amaechi Emmanuel 43.

The rest are Darlinton Ejike 30, Paul Samuel Chime 25 and 23 year-old Udo Chukwu.

Daily Trust had earlier reported that F/No. 80685, Police Corporal Olusakin Oyeniran and one Adewunmi Dada were both shot dead in the bank robbery operation at the Union bank Plc, Illupeju on March 27, 2001. The police corporal's service pistol was also taken away by the gang.

Okiro stated further that on July 31, 2001 armed robbers attacked one Mechukwu Onigire and robbed him of N283,000 along Isaac Williams Street Lagos.

According to him, a police patrol team raced down to the scene and following a gun battle that ensued, three of the robbers were killed and one pump action rifle No. L926087 with one live cartridge was recovered.

Meanwhile, the office of the Police Community Relations Committee on July 24, 2001 made a cash gift of N120,000 to the families of the slain policemen.

While taking stock of its performance in sustaining the war against crime in Lagos State, Okiro said that his men and officers are mindful of the increasing demand for public safety hence, the strengthened motorised patrol with back up within the state.

Ibeabuchi, 28, a promising heavyweight boxer who was due for a title fight, has remained in jail since July 1999 after being charged for sexual assault on a Las Vegas stripper

An official of the Nigerian Consulate in New York, Mr. Onyema Emeremni who has been following the case, told NAN on Friday that Ibeabuchi's lawyer, Mr. Robert Right had withdrawn his services after the boxer's last

court appearance in late July. Prior to his action, the defence lawyer had indicated that he would continue with the matter only after he has been paid \$150,000.

'The Lawyer's withdrawal will be a terrible blow to Ibeabuchi because his case will now be assigned to a pu-bic defender," remarked Emeremi.

Public defenders assigned by judges generally do not a good job of defending their clients.

Initially charged with sexual assault, Ibeabuchi was slapped with attempted rape, a more serious charge in the US. The incident happened in a Las Vegas hotel where the boxer called for the services of stripper who that claimed Ibeabuchi sexually assaulted her


