First Message to a Schoolmate

1.00 Preamble

The founding of messages the Lord unfolded from Heaven within a period of 7 years, 1995-2003, giving rise to the reawakening of the Global Alumni Christian Fellowship of Nigeria had been part of a set of the following growing prophetic events of visions:

- *First Message to a Schoolmate, 1995*
- *First Letter to a Classmate, 1998*
- *The Message to 9 Classmates, 2000*
- *The Global Alumni vivid vision at 40th year of a mission college, January 2001.*
- *The message to a surgeon, (a schoolmate), 2002.*
- *First Book Publication Reality of steps to life, 2002*
- *Global Alumni Reunion Newsletter, 2003*
- *The place of Nigeria in the Kingdom, 2003.*

1.10 A Brief on the Background

It was in the process of praying to the Lord in the night in the month of September, 1986, that one



had an encounter with the Holy Spirit in a night vision in an answer to a dramatic petition to God. This drastic encounter resulted in dedicating unto God my life in January 1988, in obedience to fulfill this divine mandate from heaven.

It was further realized that on account of this visitation, this calling was accompanied with a heavy burden to pray, to intercede for the ministers, the Church, and to intercede for Nigeria as a State. Further, this burden was intensified in 1989; and unto later years. The Holy Spirit then so strengthened this burden that through these intercessions the Lord, from year 1994, started sending His messenger out on errands unto individuals, to meet urgent needs of such individual persons in the society, individual persons in the Church, leaders in the Church and fellowship folds, mostly within Makurdi and later to other States in Nigeria.

This was how the reawakening started such that the Lord sent one to outside the state capital to other states in the country. He also started sending one to meet needs of, firstly Schoolmates, and



secondly, my Classmates in the subsequent years of this ministration.

It should be noted and emphasized at this point that what helped this pattern of messages to spread to other fellowships, and other towns unsuspectingly, was the fact that I maintained one local Church as a member of ECWA Church Makurdi, but also enjoyed other fellowships of interest such as the Tuesdays Bible Study and the Thursdays revival programmes in the Deeper Christian Life Ministry including their Easter retreats and annual retreats in the last month of the years.

The family in addition fully identified with Full Gospel Businessmen's Fellowship, such that one was involved in the executive as a treasurer and prayer leader and later inducted as a Life Member during the regional meeting held in Jos Plateau State in 1996.

Indeed when two of the National Leaders led by Arc Bunmi Adedeji laid his hands on me to induct



me into the Life Membership fold: **A mighty heavy wind of Holy Ghost, anointing, an indescribable heavy load of weight of the Spirit of God rested on my head, too heavy to carry on my head;** during the programme held in Hill Station Hotel in Jos.

This Holy Ghost infilling experience was an approval of a Devine sign as the Lord had singled this vision out and selected one as a message to fulfill this divine mandate, **for it was in 1995 -- the previous year,** that He had sent me to Ankpa from Makurdi to the first Schoolmate whose family was residing partly in Ankpa and partly in Lokoja. It was 2years later, also that the Holy Spirit sent me from Makurdi to the first Classmate of mine in Lagos in 1998.

It was eventually 4years later, 2000, the Lord sent one, as a Prophet to 9 classmates, who were spread all over the country. This reawakening amongst Classmates, Schoolmates and the vivid vision of a Mission College at the 40th year in January 2001, during the first anniversary of this reawakening



movement of God that has effortlessly continued to spread like wild fire (of the Alumni Christian Fellowship) to other lands on earth. It was such that during one of the 3rd anniversary meetings, the Lord had commanded us during the fellowship to in greater clarity and in further affirmation that we should reach out in literature, and to testify to 14 Classmates of mine in Budapest, Europe, who were spread all over 13 countries of the world.

2.00 The Revelation

In this way, it would become the portion of any believers that as they attend fellowship meetings; revival hours, further followed by little intercessions in the night that based on such commitments, the Lord would speak to individuals and to His Church through dreams and visions, replete on the pages of the word of God.

This was the situation with me, such that on a Thursday, in the month of March 1995 in the morning hours I received and saw a night vision. ***In that vision, I saw Abdul Alilu in shorts, and he instantly hitting his head constantly against a stout tree amongst shrubs. He kicked his head and hit it constantly against a tree. He was hitting his head and kicking his head very hard against a living tree in the vicinity.***

He did it like 2 goats fighting each other, kicking and hitting his head on the tree so fast and at a rate that could easily scatter to destroy his head against a standing tree.

He did the exercise so fast that one could not imagine or bear the pain that I quickly woke up from the dream revelation.

2.10 The Interpretation

The meaning of this revelation arising in the night has a direct clarity, a direct request from the Lord, needing instant deliverance and salvation of the Schoolmate.

The interpretation of the vision implies that Abdul was entangled in a transaction, he was entangled in a dealing; he was forced into some business with an individual or a group of people that he has the intuition or the consciousness it may even eliminate his life.

2.20 A Challenge of Relocation to Kogi State

2.21 The Challenge to Deliver the Message

We got to know each other with this Schoolmate in early 1970s, and we all later graduated as Schoolmates from the University of Ibadan in late 1970s. He relocated from Benue State where we were together for about ten years upon graduation and working, till he went to Lokoja, when Kogi State was created in 1989-90.

But given the implications of the message, one found oneself in a very difficult position because when we were together in Makurdi, we did not get to know each others residences not to talk of knowing his new location in Lokoja, a distance of about 290km from Markurdi.

Further, the message was urgent and it was not easy to plan to travel to locate and meet him in his working place, an Economist in Kogi State Investment Co. Ltd. At Lokoja, before the week would run out in view of the importance and urgency attached to the revelation message from the Holy Spirit. The position of the scriptures,

(Ezekiel 33:1-6), is that should he die in the process without the message delivered to him on this accounts, the Lord would require his blood from my hands due to negligence.

However due to rigorous inquiry, I was able to locate one of his cousins, still left behind working in an insurance firm in Makurdi. This cousin, Peter Agono, counseled me that I should go to Anpka, a town of about a distance of 120km from Makurdi, that I would most likely see him there over the weekend. This was in view of the divine timing of the instructions. He said the wife was living there at Ankpa. He described the house to me as I sketched it using some landmarks to guide me to the location.

Once I was equipped with the description of the foregoing location, the message having been received on Thursday, so I then decided I should take the risk of getting to the place in Ankpa first thing on Sunday morning, three days after the vision. I left Makurdi very early such that by 9:00am I was at his residence in Ankpa, Kogi State.

He was so shocked to see me and quickly asked me if I was traveling elsewhere, since **(we did not know each others residences, nither did we cultivate the habit of visiting each other all these years)**. He was actually lying down on a three seater chair in the parlour and was evidently troubled in the mind and appears absent minded, and while we were yet greeting each other and entertaining questions on the possible grounds for the sudden and embarrassing visit, the wife brought very hot pounded yam.

As he ate the food, he was still evidently given to a lot of thinking and meditating in the state of the mind he was before by my sudden appearance into the residence.

2.32 Delivering the Message

Thereafter he finished taking his meal, and to reduce the tension, I broke **the good news** to him as I shared from the scriptures with him.

I diligently explained from the word of God, some 4 points, explaining in divine wisdom, why the

Lord so much loved him and had actually sent me as a prophet to deliver and to save his life from premature death and destruction.

I told him point black that he was involved and being entangled in a business or transaction with someone or some persons that was capable of destroying his life.

I emphasized from the scriptures that the way the holy Spirit had spoken to me; he needed to repent to draw nearer to God for the total salvation of his household based on the contents of the warning, and admonition of the Holy Spirit from the revelation on previous Thursday morning concerning his life and destiny.

Indeed he had instant relief and deliverance from the burden of heavy yoke of death penalty that had been imposed on him and now rolled away in the power of the word of God as:

He retorted in confession to the Lord in my presence as he instantly told me that if I had come or arrived 30minutes later than I did, it

would have been too late for him and for me.

This means that the cast of the devil on his life would have been hatched into reality, had I come or arrived shortly or

longer than the meal he had just taken on my immediate entry into the house, and the first ever such visit into this residence I had made, for over 15years that we had known each other as Schoolmates.

He confessed immediately after the meal that he would have gone for a transaction and spell of death cast upon him by his opponents would have hatched into reality. He would have gone to the great beyond, and that meal would have been the last meal he would have had to take here on earth.

You see the Lord God can be so precise in timing of his events of miracles and promises of blessings as it pleases him. He has chosen to by the reasons of his messages and his plans for actions of love to deliver us and to get us reconciled, ultimately, to the Lord Jesus Christ.

My Schoolmate, Abdul Alilu, instantly gave his life to the Lord Jesus Christ and salvation entered his household this beautiful Sunday morning day of visitation of God in march 1995, as not only him but the wife dedicated her life to God.

He told me what problem it was, and I did advise him that rather than taking to idolatry and divination, he should take the matter to the law court to seek court litigation rather than seeking the option of jungle justice.

He took to the option of seeking legal counsel, over which he later triumphed in joy and victory, as I warned him to strictly take to legal action option before I decided to take my leave back to Makurdi on this fateful day of the Lord.

He before my departure, affirmed to me that on the basis of **(Ezekiel 33:1-6)** scriptures, the word of God had been fulfilled in his life and as well in the life of the messenger of God since the consequences would have been much on either one of us had the Lord not performed His word in His

own time and time and speed.

He, the schoolmate, at the point of departure, he gladly offered me some money to specifically assist my transportation but I turned him down, even though I needed the support.

This is because I would have preferred him to take the message very serious to help his growth and transformation in God.

It paid off because when I meet him the following year, he was already jubilating over the great performance of the family in the court proceedings against his adversary.

2.30 **Divine Reversal of Curse on History of a Genealogy**

The story of this message to deliver the first schoolmate in kingdom plan, is the miracle of the compassion of God, in reversing a curse on the history of the genealogy of the Abdul family from Kogi State.

God did not want Abdul to die in 1995 because it was in 1988, 7 years earlier, Abdul had lost his younger brother over the same matter of a plot of land.

Their father was a Chief and he inherited a property in the village land. When their father died, the elder people and the emerging title holders confiscated this plot of land from them and while these children were younger, the matter went to the law Court. In 1972, the case was resolved and decided by the law court in favour of the Abdul family and the confiscated plot was returned to them.

The matter surfaced again and was revisited by the contending elders of the land such that as the Abdul family fought back in 1988, he lost his junior brother possibly through demonic battles and demonic attacks and manipulations, as recorded in **(Deut. 18: 10-12)**, scriptures.
