3RD NATIONAL SUMMIT ON DIMINISHING CORRUPTION IN THE PUBLIC SECTOR/2021 PUBLIC SERVICE INTEGRITY AWARD: CALL FOR NOMINATION

In line with the Anti-Corruption agenda of the present Administration, the Independent Corrupt Practices and Other Related Offenses Commission (ICPC) in collaboration with the Office of the Secretary to the Government of the Federation (OSGF) is organizing the 3rd National Summit on Diminishing Corruption in the Public Sector/ 2021 Public Sector Integrity Award.

- 2. The National Summit is an annual event designed to review and update efforts in the fight against corruption especially in the public sector. In an effort to entrench integrity in the public sector, a significant feature of the summit will be the presentation of **Public Service Integrity Awards** to deserving Federal public servants who have performed exceptional acts of integrity in the year.
- 3. In furtherance of the above, this circular reiterates the call by the Head of Service of the Federation vide circular Ref. No. HCSF/3065/I/87 of 24th June, 2021, for all Ministries, Departments and Agencies to forward one nomination each to ICPC in the form of (i) the profile of the nominee as well as (ii) a brief description of the acts of integrity carried out by the officer in not more than 500 words.
- 4. The best two nominees will be selected for the award which will be presented by Mr. President at the 3rd National Summit on Diminishing Corruption in the Public Sector. The final date of submission of nominees by MDAs has been extended from the earlier date of C1rd July, 2021 to Monday, 16th August, 2021 to encourage service-wide participation.
