**DECLARATION MADE UNDER SECTION 9A OF
THE CHIEFS LAW, 1957, OF THE CUSTOMARY LAW REGULATING
THE SELECTION TO THE OLOWO OF OWO CHIEFTAINCY**

THE OLOWO OF OWO

There is only one ruling house for the Olowo of Owo Chieftaincy.

2. The Ruling House is AJAGBUSI-EKUN

3. Only direct sons of an Olowo are eligible to be proposed as candidates and there is no specific order of succession.

4. The kingmakers shall consist of the following seven senior chiefs:

5. The method of nomination by the ruling house is for the Ojomo to convene a meeting of the 23rd senior Omo-Olowos to consider all the candidates who have submitted their application to him. The following are the Omo-Olowos:

If only one candidate is unanimously nominated the candidate is presented to the kingmakers by Chief Ojomo. If more than one candidate is nominated, a vote shall be taken and Chief Ojomo shall present to the kingmakers the candidate who has the majority vote of the Omo-Olowos present and voting in the meeting. The kingmakers, if satisfied that the candidate has been properly selected according to the custom, will signify approval and present the successful candidate to the Iloro Chiefs who will perform all necessary traditional installation ceremonies:

Provided that if Chief Ojomo is not for any reason available to perform the above functions, such functions will devolve on Chief Aralepo.

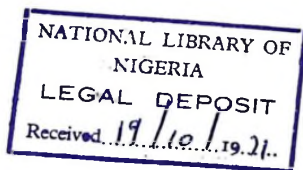

Provided that a Shashere who attains the age grade of fifty years and celebrates the Ero festival, may, during his life time with the consent and approval of the kingmakers as defined in paragraph 3 below and of the male adult elders of the family select one of his sons to succeed him; and in such case, such son shall alone be eligible to be proposed as a candidate by the ruling house at the demise of his father.

4. Succession to the Olishara Chieftaincy cannot devolve on a female line.

5. The kingmakers are the five oldest adult males from amongst both ruling houses. They should be married men and should already be taking part in the town affairs according to Native Law and Custom.
