

Rimi declares presidential interest

he race for the presidency may have be gan in earnest with the declaration by the former governor of Kano State, Muhammadu Alhaji Abubakar Rimi to contest the 2003 presidential election.

This brings to five the number of politicians who have either declared their presidential ambitions per-sonally, or done so through by their supporters.

The others include: the governor of Abia State, Chief Orji Uzor Kalu; his Zamfara State counterpart, Alhaji Ahmed Sani and the incumbent Chief Olusegun Obasanjo. Their campaign posters have already adorned the streets of major towns in the country, including the Federal Capital Territory, Abuja. Chief Gani Fawehinmi has declared interest to run under the National Conscience Party.

Rimi, who aspired for the position but later withdrew for Obasanjo who emerged winner to carry PDP ticket at the party's convention at Jos in 1998, made his declaration By Ibrahim Modibbo and Zubairu Shaba

to run again for the post shortly after he was conferred with an honorary doctorate degree by the University of Calabar last week.

"I am going to contest the presidential election, Rimi declared, adding: "there is nothing I can do than contest the presidential election in 2003, because the incumbent, President Olusegun Obasanjo has woefully failed to move the country for-

This has laid to rest speculations on Rimi's ambition and confirms an earlier story by Daily Trust on Rimi's mobilisation drive in setting up a political structure to contest the 2003 presidential elections.

While emphasising his reasons to run against Obasanjo in 2003, Rimi said "President Obasanjo did not only disappoint those that voted him into power but even those that fought to ensure that his candidature became a reality"

Senate condemns Okadigbo, accepts apologies of Haruna Abubakar, others

enate yesterday adopted a motion condemning former Senate President, Dr. Chuba Okadigbo, over certain statements credited to him even as it accepted the apologies of former Deputy Senate President, Haruna Abubakar, and other Senators indicted by the Kuta report.

The motion moved by Senator Arthur Nzeribe under Senate Standing Rule 18, Order 42, 45, 52 and 14, prayed the Senate to condemn in totality, the attempt "by certain persons" to purchase, through bribery, invoices from a National Assembly staff; and the Senate resolve that when the police had completed investigations and the "person or persons" are members of Senate, punitive action should be taken against them.

he announcement yesterday of the books of the retirement of all the three Service Chiefs through a statement signed by the Secretary to the Government of the sons not directly Federation (SGF), Chief Ufot J. Ekaette has laid to rest over four months of speculations that President Obasanjo was planning to retire some of the most senior military officers.

It, however, sparked-off more speculations on the reasons why the President had to retire the senior military officers, particularly because the five paragraph statement issued by the SGF did not state reasons for their retirement.

Weekly Trust newspaper of January 5 - 11, 2001 had earlier reported that the Chief of Army Staff (COAS), Major General Victor Malu, and nine other senior military officers in the Service would be retired by June, 2001. But to the chagrin of many defence analysts, Malu as well as two other Service Chiefs are retired two months before the reported date.

Of particular importance is the fact that the statement did not state whether the retirement of the service chiefs was due to any professional incompetence, nor did it hinge on their years of service in the military.

While the retirement of the Chiefs of Air and Naval Staff Air Vice Marshal Isaac Alfa and Rear Admiral Victor Ombu, respectively may come as a surprise to many Nigerians, that of General Victor Malu may not be a surprise to keen observers of the nation's military.

Inspite of Malu's good relationship with President Obasanjo at the inception of the present administration, reliable sources at the Defence Headquarters have hinted that Malu soon fell out of the good

President.

He started it off with a fullpage article published in some dailies attacking the former COAS and pressing on President Obasanjo to remove him (Malu) so as to rid his government of an independent-minded army chief and soften the hardline stance of his NADECO critics.

In a dramatic twist of events, however, the nine other top military offic-

ers reported to have been served their retirement notices were not included in the retirement list, going by Ufot Ekaette's statement.

The other officers earlier mentioned include Major General Y.L. Ashe, Chief of Programmes and Plans, Army (COPPS-A); Major General V.B. Williams, Director of Army Finance; Major E.E. Achibong (Obasanjo's former ADC and younger brother to Brig. Gen. Dan Achibong (Rtd) GOC 2nd Division; and Major General Peter Gyang Sha, Commandant of NDA and former GOC 3rd Division, Jos who was said to have prevented Diya and other coupists from being transferred out of Jos when Gen-



Forum seeks true federalism, The Citizens Forum for resource control

Constitutional Reform (CFCR), a coalition of more than 40 civil society organizations in Nigeria, has suggested the implementation of true federalism as a means of sustaining the current democratic process in the

The forum in its memorandum to the joint National Assembly committee on the review of the 1999 constitution, a copy of which was made available to the News Agency of Nigeria (NAN) in Abuja yesterday, declared that certain minimum standards must be adhered to in the application of the new statute.

"They include the sanctity and supremacy of the written constitution which cannot be unilaterally amended by any level of government and the nonsubordination of one level of government to the other," the document stated.

It was signed by Dr. Jibrin Ibrahim and Mr. Otive Igbuzor, convener and secretary of the forum respectively.

It also listed the direct relationship between all levels of government and citizens, as well as the independence of the judiciary and relative fiscal autonomy, as other basic standards required by the federal

It recommended a return to the 1979 constitution as regards the appointment of chief judges and High Court judges of the states.

State governors, the reforms in the nation's document stated, should be allowed to appoint chief judges of the respective states after clearance by the states' Houses of Assembly and the

local government councils in Nigeria have resolved to protest to the federal government against the continuous deduction of the primary education funds from their federal allocations.

The chairmen of all the

The federal government deducts, at source from the statutory allocations of the local councils, the financial obligations of the council which is being used in funding primary education in the country.

But in an interview with journalists in Yola, the chairman of Yola North Local Government Area of Adamawa State, Alhaji Aliyu Mohammed Attah, said that "all the chairmen of the 774 local government areas in the country have resolved to protest" against such practice.

He said the chairmen had discovered that they were being overcharged through such practice, which, he said, had negative consequences on the running of the local councils.

"The money being deducted from our allocation was too much. It is over and above what is being spent on primary education. It is really affecting us negatively," the chairman complained.

He pointed out that out of local government council's allocation alone, the federal government deducts an average of N10 million (ten million naira) monthly for primary education which, he said, was far beyond what is being spent on primary education in the area.

Alhaji Attah said that his colleagues in other local government councils have similar problems, hence their decision to unite and confront the situation with a view to

Afenifere, Senator Fasanmi maintained that he did not know who mandated them.

"Honestly, I don't know where they got their mandate from, but I know we (Afenifere) did not mandate them to represent us at that meeting'

He however said that the issue would be up for discussion during the Afenifere meeting scheduled for the Senator Fasanmi, who is country-home of its chairthe national Vice Chairman man, Chief Abraham

It would be recalled some top members of Afenifere including Senator Femi Okunroumu, Ayo Opadokun, Secretary of Afenifere and Mr. Oladipo K. Olaitan of the House of Representatives, attended the meeting of a new political association, National Frontiers, in Abuja last week.

This move, many people believed, was an attempt by the Afenifere to dump the AD for another political party Okunrounmu and Opadokun. however, affirmed that they attended the meeting at the instance of the Afenifere group which was invited by the National Frontiers.

But Fasanmi, a second republic Senator, maintained that the situation would not cause any problem to the group, as the leadership of Afenifere would handle the issue maturely.

The Minister of State for Foreign Affairs, Chief Dubem Onyia, has called on the Christian Pilgrims Committee to ensure Ekwunife. that no pilgrim to the Holy

Land absconds this year. The minister, who gave this charge while inaugurating the committee in Abuja commended the board for the reduction in desertion recorded during last year's pil-

Chief Onyia advised the committee to work towards early take off of this year's pilgrimage, adding that the government would provide adequate resources to facilitate the committee's work.

He, however, restated that the Federal Government would from next year scale down the level of its involvement in Muslims and Christian pilgrimages, and limit itself to consular services.

Globalisation: A dirge to local industry

t a recent meeting with President Olusegun Obasanjo in Abuja, the Nigerian Association of Chambers of Commerce, Mines and Agriculture alerted the federal government on the plight of the industrial sector. Led by its President, Alhaji Shehu Umaru Ndanusa, the association cautioned on the imminent danger, which a "full-throttle trade liberalisation" meant to local

Indeed, since the late 1980s the private sector has consistently cried out over the fact that, "the full-throttle liberalisation policy has made our economy vulnerable and porous to importation of goods that could otherwise be produced locally."

Recently the Nigerian Tailoring, Textiles and Garment Workers Union (NTTGWU) pointed out that because of the free for all importation and dumping of cheap textile materials from the Asian countries, over 150 textile industries have closed down. Speaking through its secretary-general, Comrade Issa Aremu, the union said it is only a matter of time for the few remaining to fold up. The union which carried its crusade to the National Assembly recently, said the full-fledged trade liberalisation of the economy sounded the death knell for the sector. They pointed out that Nigerian jobs are being taken away and given to textile workers in Asia and urged the federal legislators to take steps to redress the situation.

The same refrain could be heard from the agro-processing sector where the indiscriminate importation of numerous canned foods is threatening local food production and processing sector. Today canned beans, potato, rice, fruits and numerous other items could be found in our markets and department stores while those locally produced rot away in warehouses simply because those imported are cheaper than their local version. The story is the same with toiletries, electronics, chemicals and engineering.

The devastating effects of dumping in the name of trade liberalisation make it imperative for the government to take some drastic steps to check the trend. In this respect, we identify with the call on the government by the private sector for the creation of an anti-dumping commission with adequate representation from the organised private sector.

At a recent interactive session between the House of Representative Committee on Finance and the Ministry of Finance and CBN, participants identified low productivity as the reason for the drab performance of the economy. They also fingered inadequate infrastructures such as electricity, communications, and transportation among others as the cause of this uncompetitive production costs in Nigeria. By excessive reliance on imported goods, our economy is unwittingly sustaining jobs in those countries where such goods are imported while we continue to grapple with the scourge of unemployment. In fact a conscious effort to support local industries would go a long way in alleviating poverty than the Federal Government's pet Poverty Alleviation Programme (PAP) and its successor, the Youth Employment Scheme (YES) could do.

We note with concern the lack of a coordinated policy towards making thriving industries a source of employment by the present administration. For instance the economic blueprint of the Obasanjo administration, Nigerian Economic Policy (1999 – 2003), does not appear to emphasise industrial production as the thrust of its job creation strategy. Although it says the economy would be private sector driven, paragraph 15, under "Employment," only said; "to promote the goal of full employment and address the critical concern of youth employment, government will support the activities of the National Directorate of Employment (NDE) and Macro Credit Institutions while concerted efforts will be made to encourage and promote self-employment". To this strategy, we believe, should be added job creation through small and medium scale industries.

Finally, it will run counter to the grain of economic policy to canvass outright prohibition of goods that compete favourably with local ones but there is a measure of protection that local industries, where we are at a comparative disadvantage, should be given. Even within the framework of world globalisation there is room for a period of grace within which to allow sectors where we are lagging behind to catch

This is because in the final analysis even within the framework of globalisation every country will still carry its own flag and bear its own peculiar problems.

Matters arising

see that my piece on "Resource Control: the greed factor" on these pages two weeks ago has provoked the anger of Midebo Bayagbon who writes for the *Vanguard*. Writing in the April 18 edition of the paper, Bayagbon. whom I suspect is from the oil producing Delta region, gave me the verbal lashing of my life. Not since Reuben Abati, The Guardian's wordsmith said I am a rude person and an intellectual of the Jihad for defending Sharia, have I been so tongue-lashed.

"Reading that crafty piece by Alhaji Mohammed Haruna, one of the few northern elites who has had something like a respectable career to his name", Bayagbon said of my article "I was greatly saddened that one of those I used to have some measure of respect for in journalism, could be so trite, so insincere, so manipulative and so greedy." My article, he further argued, showed I was merely trying to please some core northern elites whose stock-in-trade is to loot the treasury, buy flashy cars, build mansions in Abuja, Kaduna or Kano and export the bulk of their loot abroad. Bayagbon felt so strongly about my article that he captioned his rejoinder, 'Mohammed Haruna and greedy northerners'

In spite of their harshness, however, you get the feel of the depth of Bayagbon's animosity against the so-called core northern elite, not in those words but in an earlier paragraph. He says in that paragraph that when Chinua Achebe wrote once-upon-a-time, that the problem with Nigeria was that of its leadership, the famous novelist was merely being nice. Achebe, Bayagbon says, "might well have written that the problem with Nigeria is the problem of the northern elite's: indolent, greedy and parasitic"

What did I say to provoke such strong diatribe against myself and fellow northerners? For those who may have missed my piece, all I said was that the primary motivation for both sides to the debate for control over oil is greed rather than the well-being of the majority poor Nigerians.

Bayagbon is angry that I should call those demanding for resource control greedy. With people from the oil-rich Delta region suffering from all these years of terrible neglect when they see oil wealth being used to develop Lagos, Abuja and elsewhere, it is understandable that any Delta indigene will be angry at being called greedy for demanding full control of what is underneath his soil.

Such anger, however, is not an excuse for Bayagbon's emotional outburst. Before I address his blind and somewhat unhelpful anger, however, let me take you back to another piece by another critic of mine on another topic altogether. This is the piece on The New Nigerian. Turi and I (January 24). The piece was a review of sorts of the book by Malam Turi Muhammadu, a former editor and managing director of the New Nigerian, on the first 20 years of the paper. It was also a bit of the story of the critical role the paper had played in my journalism career. Abu's rejoinder was carried by the Daily Trust of February 28.

Abu, whom I suspect was a ghost-writer, took very strong exception to my suggestion that the decline of the New Nigerian started in 1979 when Alhaji Tukur Othman took over the paper as managing director and meekly submitted to the federal government's interference with its editorial policies. Abu argued that I, as managing director from 1985 to 1989, was solely responsible for killing the paper out of my inexperience. He also made innuendos of financial improprieties on my part as one of the reasons for the decline of the paper and the collapse of my own magazine, the Citizen. He even insinuated, for good measure, that I killed the Peoples Bank of Nigeria on whose board I was!

My suspicion that Abu ghost-wrote the piece was because it mirrored the views of some insiders in the affairs of the New Nigerian who have never been happy with my career path in the paper. Some of them had the courage to say so publicly and of course, I had responded to their views as I robustly as I could, a response which led some of them to call for a truce. Apparently, they misunderstood my article as calling off the truce and so they decided to rejoin issues with me. This time, however, they seem to lack the courage to use their own names

I have two other reasons to suspect Abu is a ghost. First, he gave the editors of Daily Trust a non-existent address as his. My own search in Kawo, Kaduna and enquiries from long time residents of the neighbourhood revealed that there is no Lemu Road there. Second, Abu tried to hide the facts with a pretence to having an inside knowledge of how I became managing director. The first distortion was that I became managing director at 29. The fact was that I was 35, which was not so youthful, considering General Yakubu Gowon became Head of State at 32 and long before him, people like Chief Mathew Mbu and Alhaji Maitama Sule became Federal Ministers at well below 30.

The second distortion, which actually is a bare-faced lie, was that I lobbied to become Federal Minister of Information. The truth was the exact opposite; 1 lobbied - if that was the word - NOT to become minister. At the time in question, rumours of possible candidates for the job, including mine, were flying around. At that time I was already managing the New Nigerian and I thought I wasn't making a good job of it, not from the professional side, but rather, from the management side as I was having problems keeping up a respectable circulation figure in the market and paying salaries as at when due. This was mainly because the owners were not giving me the usual grants.

When I heard rumours of my possible appointment as minister, I quickly ran to President Ibrahim Babangida then on a holiday break in Minna, and reminded him that our deal on being appointed managing director was that the paper would be sufficiently funded. Instead, I was hearing these rumours of being moved over as minister of information because the paper had not been sufficiently supportive of the government. As I remember it, Babangida asked me where I heard the rumour from and I said it was all over the place. He dismissed it and subsequently approved a grant of N2,000,000 for the paper, a sum which barely scratched the surface of its financial problems. Even then I got only half of it before I finally got the boot in February 1989.

On this issue, I thought it was instructive that when much later on I visited the late Col. U. K. Bello - Babangida's ADC and a

childhood friend - in his Dodan Barracks office, and the issue came up, he riled at me in Hausa as someone who will die a pauper, not because he thought public office was for taking personal advantage - he didn't - but because he thought I was too scared of its challenges to gain anything from its benefits.

To return to our angry friend Bayagbon: obviously, he holds a view which is widely shared among southerners - their elite and commoners alike - that Northerners are simply spongers on the national economy. There are, of course, a few exceptions to this view. One such prominent exception was the late Ken Saro-Wiwa.

In 1990, Ken told the Daily Times in an interview that as far as he was concerned, the Yoruba, and not the much-maligned Hausa-Fulani, have gained most from Nigeria's petrodollars. Predictably many Yorubas came down on him like tonnes of bricks. One respondent called Ken a coward and a disappointment and said he would stop reading his popular column, Stmilia, in the Sunday Times. Another, who was rather personal, said Ken was merely compensating for his short stature by developing a huge ego. Yet another, who was even more personal, sought to remind Ken that the Ogonis were cannibals, once-upon-a-time! And so on and so forth.

Far from being cowed by these reactions, Ken chose to re-affirm his position in his Sunday Times column on August 12, 1990. Under the title "Yorubaphobia", he insisted that "Yes, indeed the Yoruba have been the main beneficiaries of the petrodollars of the Niger-Delta and environs. The loss of the Qgoni, ljaw, Urhobo. Isoko. Ekpeye, Ogba, Jkwerre, Ibioro and Igbo has been the profit of the

In his inimitable plain speaking and simple diction, he sought to dismiss all accusations that he was a: Yorubaphobe for merely stating that the Yorubas have benefited most from Nigeria's oil. He said he admired the Yoruba for their contribution to Nigeria just as he was critical of them for their negative qualities.

he argued, "is not whether pipelines are "The problem. going from Ogoni to Akure, Ibadan and Lagos. They do. Metaphorically, if not in reality. Nor is it whether the Yoruba have got as much or more than the Hausa-Fulani. It is whether . . . the Yoruba can take all of us along the path of Nigeria that is fair to all ethnic groups, that Nigeria envisioned by the great African visionary and intellectual, Awolowo. For to whom much is given, much is expected

Ken, as I said, was an exception among Southerners. Most Southern writers tend to agree with Bayagbon that Northerners are mostly, if not solely, to blame for the ills of this country. For example, writing in *The Comet* of February 11, Sina Odugbemi, one of its foremost columnists, said "Many, if not most of the radical proposals for restructuring the federation are a reaction to domination by the core north. People have been provoked and badly scared."

However, widespread as Bayagbon's and Odugbemi's views are in the South, they, as well as Ken, are wrong. Dead wrong. The socalled core North or even the wider North is no more responsible for the ills of this country than any other section or tribe. The problem with the ethnic perspective to the country's problems is that it distorts, or even ignores, the true class nature of the marginalisation of the vast majority of Nigerians whose lives have never been touched by oil money. In this regards, the most accurate insight into the issue was by one Sola Oke in reaction to Ken's "Yorubaphobia". Oke said among other things, that "The vast majority of Hausa-Fulani, the Igbo, the Yoruba, the Birom, the Efik, the Urhobo, name it, Sir Kay, are the true majority. It is you and I and the rest of the privileged class that are minority by virtue of cornering the bulk of the national wealth and prospects

This "pampered" minority, he emphasised existed in all ethnic groups and other Nigerians were virtually their prisoners. It was true, he said, that the Yoruba controlled the higher percentage of the privileged class than the Ogoni and the Ijaw, and presumably the other ethnic groups. Even then, he argued, reversing the percentages of the ethnic members of this class is not the solution to Nigeria's

The real war, writers like Bayagbon and Odugbemi must accept is, as Oke concluded, not between the Yoruba and the Hausa-Fula and the Igbo and the other ethnic minorities - North or South. 1. real war is between the real majority impoverished Nigerians and "the selfish and insensitive minority" to use Oke's word. This class paradoxically includes columnists like Bayagbon, Odugbemi and myself. It is the greed of this class that I talked about when I wrote the piece that enraged Bayagbon so much, he apparently believed the best way to respond was to call me and all other Northerners every nasty name he could dredge up from his dictionary

Africa: A call for peace

Professor Festus Okafor, a highly respected scholar and philosopher at the University of Nigeria, Nsukka, Enugu State, made what is widely regarded as the most beautiful philosophical commentary on Africa.

He made this highly informative, educative, and philosophical remarks in his widely acclaimed book titled: "Africa at the Cross Roads." hen African Heads of State meet in Nigeria this week to discuss an African strategy for the war against the HIV/AIDS pandemic stalking the continent they should be taken seriously. The same is true for South Africans gathering in Johannesburg to discuss the importance of civil society in their country.

Having former US president Bill Clinton hanging around won't help.

From Harlem to Abuja, our former President just can't seem to get enough of the company of black folks - and our admiration and gratitude! Such sentiments are not only wildly misplaced, they are dangerous.

The triumph of symbolism over substance is the true Clinton legacy in the African world. If African and African American leaders alike do not distinguish between the two, and insist upon the latter, the next generation will suffer.

Consider the price already paid:

During his first term in office, President Clinton withdrew US troops from Somalia and established the unspoken rule that no African concerns were worth risking American lives. The rule holds even in places where Washington has deep historic responsibilities for the problem, as it does in Mogadishu, and despite the fact that US armed forces are disproportionately of African descent. Clinton's administration not only failed to act against the genocide in Rwanda, it prevented the UN

Clinton's symbolically important 6-country Africa visit in 1998, including an airport apology in Kigali, Rwanda failed to produce sustained US support for peace, development and democracy in Africa.

Nor did the decision to bomb an aspirin factory in

Khartoum, following attacks against US embassies in Nairobi and Dar es Salaam, address the real security needs of Africans in

The visit also coincided with the introduction of US special forces training for Nigeria's military, which has shouldered the bulk of West African peacekeeping



Lebanese Prime Minister meets Pope

he Lebanese Prime Minister Rafiq Hariri has met Pope John Paul at the Vatican for a meeting concentrating on the Middle East

"The situation in Lebanon and the dramatic situation in the Middle East were the main themes of the talks," Vatican spokesman Joaquin Navarro Valls said.

Mr Hariri's visit to Rome came a week after an Israeli air raid on a Syrian military position in Lebanon and less than two weeks before the Pope is due to travel to Damascus and the city of Quintera on the Golan heights.

Unofficial sources said the Pope and Mr Hariri discussed the air raid, relations between Lebanon and Syria, and the papal visit to Syria.

Vatican spokesman Joaquin Navarro Valls told journalists that the Holy See believes international law and United Nations resolutions should be respected and negotiations resumed to further the Middle East peace process.

"The Holy See is taking the opportunity to stress once again that reconciliation is important

and an essential element for human and social reconstruction in Lebanon," he said.

The current high level of tension between Syria and Israel started last week with an attack by Lebanese Hezbollah fighters on an Israeli outpost in a disputed area where the borders of Lebanon, Syria and Israel meet.

One Israeli soldier was killed in the Hezbollah action, provoking Israel to warn that it held Syria responsible for such

Retaliation followed in the form of an Israeli air attack on a Syrian radar station in Lebanon which left three soldiers dead.

In his talks with the Pope, Mr Hariri, a Sunni Muslim, explained that it was in Lebanon's national interest for the Syrian army to remain there, Lebanese radio reported.

Mr Hariri was quoted as saying in an interview with Vatican media that the Syrian presence helped "entrench security and stability and helps us face the Israeli attacks in various fields'

Mr Hariri has travelled on to Washington for talks with President George W Bush on rebuilding the Lebanese economy and the country's sensitive position between Israel

Tshisekedi returns to Congo DR

profile Democratic Republic of Congo opposition leader has returned to Kinshasa after 15 months in

Tshisekedi is in the DRC to participate in the planned "inter-Congolese dialogue" that is part of the peace process aimed at ending the two-and-a-half-year war in the country.

He has been a major figure in the country since independence and was a leading critic of former dictator Mobutu Sese

His return signals progress in the peace process that was kickstarted by President Joseph Kabila who succeeded his assassinated father Laurent Kabila in January.

In advance of Mr Tshisekedi's return, pro-government newspapers in Kinshasa were reporting on what they described as his plan to destabilise the

But on his arrival in Kinshasa Mr Tshisekedi made it clear that he was not interested

Mr Tshisekedi fell out with Laurent Kabila soon after the latter ousted Mobutu Sese Seko

He was banished from Kinshasa and placed under house arrest for breaching a ban on

At the time he was told to stay out of politics until the transition democracy occurred.

Armed men rob South African AIDS boy

hree armed men have robbed the Johannesburg home of dying 12-yearold South African Aids activist Nkosi Johnson.

His foster mother, Gail Johnson, said the robbers broke in early on Monday, held up a nurse who was watching over Nkosi and threatened to shoot her if she made any noise.

Ms Johnson said she thought Nkosi, who has Aids-related brain damage and has been semicomatose since early January, had witnessed the robbery.

The nurse overheard one of the robbers telling the boy to close his eyes before they fled with electrical goods and Ms Johnsa:

Ms Johnson said she believed she scared the robbers off when she woke up and ran to Nkosi's room to see what was happening.

"I don't know what this is going to do to him, as he saw everything," she said. "I am very ingry and scared. This is a

They covered the nurse with a duvet and pointed a handgun at her and told her that she had to keep quiet, otherwise they would shoot her.

Ms Johnson said she had asked for police protection, but had been told there was a shortage of manpower.

"I am going to have to organise 24-hour security now,' she said. "They are lucky I don't have a gun, otherwise I would have killed them.'

Nkosi was born HIVpositive in Johannesburg in 1989 and given just nine months to live, but he survived and on 4 February turned 12.

The schoolboy became a leading public figure in the fight against HIV and Aids in 1997 after a group of parents opposed his admission to school because of his HIV status.

At last year's World Aids Conference, he made a moving plea to President Thabo Mbeki to give victims of the disease anti-retroviral drugs.

Briton suspected of foot-and-mou

The Department of Health in Britain is investigating a report that a Cambrian slaughter man may have contracted the foot-and-mouth

If confirmed, the case would be only the second ever recorded in Britain, although experts say the illness is only mild in humans, and that no cases of human-to-human transmission have ever been recorded.

The reports add to fears over human health in relation to the crisis - with concerns over the release of carcinogenic dioxins from animal pyres.

Environment minister Michael Meacher conceded that the pyres could be a health risk.

The patient, from west Cumbria, had been heavily involved in the culling operation currently underway in the region, and as such was in regular, close contact with infected animals.

Dr Peter Tiplady, of North Cumbria Health Authority, said: 'The man was accidentally sprayed with some material from a cow, and two weeks later developed symptoms similar to that in the animals - ulcers in the mouth and sore, itchy hands.

"It is not a very serious less. He is not at all unwell

and we expect him to make a complete recovery.

Scientific advice is that it is highly improbable for the virus to pass from animals into the human population under any other circumstances, so the general population is not at risk.

Angus Nichol, director of the communicable diseases surveillance unit of the Public Health Laboratory Service, said: "Basically this is an animal virus it doesn't like human beings.

"If you expose someone to massive amounts of the virus, they may get the disease, but they probably won't."

He said that when humans did contract foot-and-mouth, it was a very mild illness for them, which invariably cleared up within a matter of weeks.

However, a spokesman for the Department of Health said that it was aware of the case, and that the slaughter man in question had "all the symptoms' of the illness.

A spokesman said: "Footand-mouth in humans is very rare but it can occur - this case is being investigated urgently.

"However, foot-and-mouth is a mild illness in humans.'

Officials said that the case ild not be confirmed for at

least 48 hours, when the results of blood tests would be returned.

The symptoms are similar to another virus - hand, foot and mouth - which is completely

The previous single human case in the UK was during the 1966 outbreak. The patient suffered no long-lasting effects to his health.

Professor Tony Hart, an expert in infectious diseases at the University of Liverpool, told the BBC: "Foot-and-mouth is predominantly a disease of animals, which, on very rare occasions is transmitted to humans

"I imagine it would be transmitted through close contact between individuals and animals who are infected.

He said he was not aware of any other case in which a human, having picked up the infection, passed it onto another human.

However, he said that it was possible that an infected human could pass the virus onto animals - which are far more susceptible

He said: "One can never say there is no danger but there have been no cases reported.

A spokesman for the PHLS said that it had been alerted to several suspected human cases of foot-and-mouth since the beginning of the outbreak - but tests for the virus had proved negative in each of them.

A spokesman said that human foot-and-mouth was "not a big public health issue'

He told BBC News Online: "Although we are keeping a lookout for this kind of thing, it really is vanishingly rare.

Another explanation for this illness is the most likely answer.'

The space tourist, US multimillionaire Dennis Tito, left for the launch pad at Baikonur in Kazakhstan on Monday.

Mr Tito "will travel to the [International Space] station no matter what", Russian Space Agency spokesman Sergei Gorbunov said.

The US space agency NASA has opposed Mr Tito's flight, saying that he may be a danger to his fellow crew and to the ISS.

We will guarantee Mr Tito's safety during the flight," Mr Gorbunov told reporters on Monday.

It is not clear whether NASA could stop Mr Tito entering the

space station if it wanted to.

Mr Tito himself was in a buoyant mood before leaving Star City, near Moscow.

"I feel very confident. Both my commander and flight engineer feel that we'll have a very successful flight," he said. If all goes to plan, Mr Tito

will be flown into space on a Russian Soyuz mission to the International Space Station (ISS) commander Talgat Musabayev and flight engineer Yuri Baturin on Saturday.

"I will be doing my own experiments, both stereo and video photography as well as still photography. And also hope to enjoy the beautiful view of the Earth," he told journalists.

Mr Tito and his fellow cosmonauts are due to dock with the ISS two days after launch.

They will return to Earth on 5 May

The Russian space authorities have taken out a standard \$100,000 dollar (£69,000) insurance policy on the lives of each of the three Soyuz crew, including Mr Tito, the Russian news agency ITAR-TASS says.

The US space shuttle Endeavour is now docked with the platform and will undock on Saturday.

The station's current resident crew is commanded by a Russian, Yury Usachev.

He is accompanied by US flight engineers James Voss and Susan Helms.

The trio are spending four and a half months aloft and are due to return to Earth on the Discovery shuttle in July.

US retires submarine commander The commander of the American

submarine that sank a Japanese fishery ship off Hawaii in February has been reprimanded at a final hearing into the accident and forced to retire from the US Navy.

Commander Scott Waddle was found guilty of dereliction of duty at a hearing in Honolulu presided over by the commander of the US Pacific Fleet, Admiral Thomas Fargo.

Nine Japanese students and sailors were killed when the submarine, USS Greeneville, surfaced beneath their ship, the Ehime Maru, sinking it within minutes.

Admiral Fargo said the submarine's crew had known there were ships in the vicinity, and would have avoided the collision if they had made a proper periscope search.

"This collision was solely the fault of the USS Greenville, he told a news conference following the hearing. "This accident could and should have been avoided."

A naval court of inquiry had earlier recommended against holding a court-martial which could have led to Commander Waddle's imprisonment,

because it found no evidence of malice or criminal intent.

He had already accepted responsibility for the collision between the two vessels.

An investigation heard that the submarine would not have been at sea at all were it not for a group of civilian visitors that a retired admiral wanted to take on a tour.

It was claimed that there were failures in the sonar tracking of the Japanese ship and that because Commander Waddle had spent so much time with the 16 visitors at lunch, the submarine fell behind schedule.

Commander Waddle's lawyer said he would retire from the US Navy with his rank intact, on a full pension, with a honourable discharge.

In a statement afterwards, Commander Waddle said: "I understand and accept the punishment that Admiral Fargo has imposed.

"This hearing concludes a very difficult time for my family. It has effectively ended my navy career. It was not the end I had envisioned.

"While I regret that my navy career has ended in this way, I know that I am one of the lucky



Ciroma affirmed that it is in the interest of the country to ensure that it establishes "confidence and good relationship" with the IMF and the World Bank. He said the two institutions are of particular importance to the country because other nations of the world depend on them to form their economic opinions or views about Ni-

The \$97 million or N13.1 billion credit facility is an interest-free loan granted for communitybased poverty reduction projects in Abia, Cross River, Kogi, Benue, Yobe, Gombe, Ekiti, Enugu. Kebbi, Delta, Osun and Zamfara States. It is repayable within 35 years with a moratorium of 10 years. It, however, attracts a service charge of 0.75 per cent.

FANN workers threaten strike action

Shippers Council to re-activate the operations of inland container ports gathers momentum, the Steering Committee Chairman, Kaduna State Shippers Association, Mr. Steve Amadi, has pointed out that the only way to effectively operate dry ports is to dump the 1999 port reforms report and upgrade the inland container depots to the states of dry ports.

Meanwhile, the Kaduna State Shippers Association has agreed to seek the audience of the Vice-President, Minister of Transport, and the Kaduna State Governor on the need for total overhaul of Inland Containers Depots at the hinterland, particularly in Kaduna State where there is an existing infrastructure on ground, instead of constructing new ones.

The minister said when he received in audience a business delegation from the Netherlands in his office in Abuja, that the dredging of the river is "extremely" important to the present administration.

Maduekwe noted that it will make the country accessible to investors and businessmen from the whole world and make Nigerians have easy access-to products of other countries of the By Ahmed Shekarau

He urged members of the Dutch business delegation to avail themselves of the abundant investment opportunities in various sectors of the Nigerian economy, stressing that the present investment climate in the country is open to foreign investments. He said the on-going privatization programme in Nigeria is "a no-horse-barred privatisation"

Responding to a question by a member of the Dutch business team on Nigeria's cabotage law, the minister noted that in accordance with the nation's new democratic culture, the National Assembly is conducting a public hearing on the matter with a view to reviewing the situation.

Maduekwe explained

further that: "Cabotage is the big buzz word now in Nigeria," adding that the government is very cautious in handling the issue.

He noted that Nigerians differ on whether or not to abolish the law. "While some people want us to

adopt cabotage culture, others believe we should look at it critically from our own background.'

He said central to the issue is the government's efforts to revive the shipping industry, which has been comatose for years, noting that "the National Assembly is providing a very strategic culture through the public hearing."

In his response, the leader of the delegation, who is also Netherlands' Ambassador to Nigeria, assured the minister that the Dutch business delegation will scout for many investment opportunities in the country, particularly in the transport sector.

Other members of the team include the Dutch Minister of Foreign Trade, as well as representatives of several Dutch companies such as Amsterdam Port Consultants and Hasconing Engineers Ltd.

Kuwait to shutdown refinery for 35 days

uwait plans a total shutdown at its Shuaiba refinery for 35 days as from April 28 for general repairs to eventually lift output to the design capacity of 195,000 BPD from a current 120,000 BPD, an industry source said.

"This is a general repair plan which could cost over a million dinaps (\$3.3 million) and is expected to restore the refinery to a new standard to meet its design capacity," an oil industry executive familiar with the repairs said.

The executive said the plant, the smallest of three domestic refineries, had been running at around 120,000 barrels per day (BPD) in recent months.

"There are problems at area eight, one of the units

is not operating well but after the repair work, it will come back to its fully capacity and all the vessels will be open," he added.

"The repair work is also aimed at avoiding (future) accidents", he said of the refinery which was hit by an explosion last year that killed two Kuwaiti workers.

Shuaiba operations were not affected by the blast but the country's largest refinery, the 450,000 BPD Ahmadi, was forced to close down in June when six people were killed in a huge explosion. It is now operating at around 285,000 BPD.

While Mina Abdullah refinery has a capacity of 285,000 BPD, Asian markets are the main customers for Kuwaiti products.

Bida: The art of weaving

t Bida there are numerous guilds and groups of artisans, and it is difficult to discuss Bida, this mobile cultural capital of the Nupe speaking people, without considering these guilds or groups of artisans, and the activities of each.

The abundance of talent in man, together with the sheer wealth of the physical environment seems to have resulted in the preponderance of these groups of artisans at Bida, and you encounter them at every turn. These may be blacksmiths, or brass smiths, or the weavers of Bida, who are almost eternally busy at their looms.

The physical growth of Bida town is closely related to the presence of these guilds which have expanded over a period of time and attracted a vast clientele in the process, while also providing jobs for many. These guilds also have a coterie of officials who are classified as leaders of the various bodies.

Thus, there is a sense in which one can view Bida as classical example of how guilds of craftsmen played a powerful, though subtle role, in the growth and development of a community.

The weavers of Bida are one such group which has a subtle but vital influence in the community. A source who would not like to give her name opined that weaving requires a lot of patience, the power of concentration, and also an eye for beauty and detail. 

'Hustlers'invade Abuja night life

t is 6:15 p.m. on a Friday. A taxi stops by the Wuse Zone 4 corner shop. Four girls in their 20s, well-dressed and well perfumed, alight and make their way into a nearby restaurant. Seconds later, another set arrive, and head for a hidden restaurant just by the road. And in another minute, more arrive. You would think they were coming for a party. It's no party, at least in the sense one knows of a party, where a particular celebration takes place. These girls, most of who appear decent, and speak impeccable English, as I later discovered, have come to "hustle" for men. They would hang around restaurants, cafes, or bars till dusk, when night life begins. The approach of dusk is the approach of cash. Then, their patrons, after the day's job, go out to relax, drink and select any 'beauty' they behold. They come in different shapes, complexions, dressings and styles. What is common amongst them, however, is that they are all after cash. Not just cash, but real cash. They hunt for it, as long as necessary, even if it means hanging out till dawn.

My friend, Daniel gave me a first hand experience the other night. He had walked up to a girl, and I listened to their conversation after a drink.

"Hi," Daniel had called, "what is your name?"

"Linda," came the reply.

"I feel like getting closer," said Daniel.

"Where do you stay?" enquired Linda.

"Wuse Zone 6."

"I take N3000 for a night,"

"I will give you N1000."

"Not my type," replied Linda, and she walked away. Daniel and I looked at each other obviously ashamed. What amazed me was Linda's lack of appreciation for the drinks and chicken which she had made my friend to buy. She consumed them and shunned my

Moments later, a Lincoln navigator jeep cruised by, and after a few seconds of silent negotiation with the elderly occupant, the door opened and Linda was driven away.

Cookey-Gam said that government was committed to upholding the rule of law, noting that it would not fail in its duty of maintaining law and order.

She commended the late Rotarian Larry Hout for putting in so much efforts into raising funds for the establishment of the national polio laboratory in the hospital.

Expressing the Federal Government's appreciation to the World Health Organisation (WHO) and Rotary International for their contributions toward equipping the laboratory, Dr. Ndalolo assured that government would take immediate steps to ensure effective functioning of the laboratory.

203 persons die in auto accident in Ogun state

total of 203 people died in auto accidents in Ogun state during the first quarter of this year alone.

In a statistics of road traffic accidents and offences in the state for the first quarter of this year made available to Daily Trust yesterday in Lagos, over 362 persons were allegedly injured in road mishaps in the state.

It was gathered that the state recorded about 294 accidents during the period. In all, 54 of such accidents involved vehicles. The statistics revealed that 125 of such accidents were serious while 113 were fatal.

It was learnt that, police charged 77 persons to court for accident related offences. Daily Trust was told that one person has been corrected so far while two were discharged and acquitted.

Daily Trust gathered also that in all, a fine of N5,010 was

imposed while one person was sentenced to one month imprisonment in a traffic related offence. The report indicated that a total of 233 cases were reported as road traffic offences.

It was learnt that over 23 cases were being currently prosecuted, stating further that a similar number (23) persons were also convicted for traffic offences in the state.

Daily Trust investigations in the traffic department of the state police command revealed that over 60 percent of the accidents occured along Lagos/Abeokuta expressway. It was also gathered that bad road and activities of hoodlums along the highway contributed to series of senseless killings in automobile crashes in the state.

AD Chairman wants government to monetise allowances

he national chairman of the Alliance for Democracy (AD), Alhaji Adamu Abdulkadir, has urged the Federal Government to speed up the monetisation of allowances of political appointees and those of civil servants.

This, he said, would stop the drain on government resources. Abdulkadir told the News Agency of Nigeria (NAN) in Abuja yesterday that it was not the responsibility of government to accommodate its appointees, buy cars and employ drivers for them.

"If the allowances of government appointees are monetised, such officers will be forced to rent their own houses, buy their own cars and employ their own drivers, and the money spent on such perquisites could be diverted to something else," he said

The AD chairman said that if a minister was removed from office, he would not have to think of where to go or how to return government property since he already had his own.

Abdulkadir said that government has lost a lot of money through the carelessness of some drivers who smashed government vehicles with reckless abandon,

pointing out that if allowances were monetised, government would no longer bother itself about replacing official vehicles.

He also said that the monetisation of allowances would lead to a fall in rent, particularly in Abuja because some appointees would prefer to go outside Abuja to secure accommodation.

"Monetisation is what government should do from the ministers downward and forget about housing them. They should also encourage mortgage institutions to build houses for sale to workers," the AD chairman counselled.

Abdulkadir also suggested that government should encourage banks to start giving loans to civil servants to enable them to build

He said, therefore, that the results, which showed that the PDP candidate won by 100,190 votes, followed by Mrs. Martina Soloman of the APP, who got 9,720 votes and the AD candidate who got 2,110 votes, were fake.

He said, he would sponsor a bill in the Senate that would prescribe punishments against INEC officials who capitalised on their sensitive positions to rig elections in favour of others.

Senator Aruwa also described the suspension of oil explorations in the north as the handwork of some antinorth elements in the govern-

ment, and said that the north may be compelled to raise funds to finance explorations in the region. He reasoned that it took 20 years to discover oil in the Delta area so it was too early for the government to suspend exploration in the north just after about one year, adding that "with or without oil, it was time for the north to look inwards with a view to curtailling the blackmail of the oil producing states. Aruwa also attributed the failure of the Nigerian economy; fall in the value of the naira and increasing poverty to the poor leadership of President Olusegun Obasanjo.

On the recent decision of the Senate to implement the recommendations of the Kuta Panel's report as suggested by the Oyofo committee, Senator Aruwa, who was also one of those indicted by the panel said he was ready to abide by it. Matori, who represents Bauchi Federal Constituency, told his people in Bauchi at the weekend that the Presidency was to be blamed over the non-provision of roads, boreholes and health centres in each constituency.

"The 2000 budget made provision of about N80 million for the amenities but President Olusegun Obasanjo failed to provide the funds in preference for a new plane which the Lower House also rejected," Matori said.

He explained that the Lower House was willing to approve the purchase of a new plane for the President provided he included the provision of amenities to the contituencies.

He said that the 2001 budget made provision for a 200-km road, three boreholes and a medical centre for each federal constituency and blamed the Presidency for failure to release the funds.

While pleading with his constituents for understa. ding, Rep. Matori said effc is were being made to convince the Presidency to include the provision of amenities with the request for a plane is cause of the importance of the amenities to the elector-

Self-defence for women

and attitude, meaning that women must be aware of their surroundings at all times, so they can protect themselves if ever faced with a potentially dangerous situation. Sisters can increase their confidence level (aka "street smarts") by joining a gym, taking boxing lessons, practicing Taebo at home, or enrolling in self-defence classes. These women know that there are no guarantees when it comes to protecting themselves, but being men-tally and physically prepared can increase their options and can lead to a successful escape from danger.

Knowledge is power, so arm yourself with the following information provided by law enforcement officials and safety experts. According to experts, there are some simple self-defence tips that can make you safer at home, at work and at play.

Don't make yourself a target

Looking vulnerable (walking down the street with your head down, slouching, looking lost, or carrying too many bags) is an open invitation to a potential offender, says Ronald Hampton, executive director of the National Black Police Association. "Most of the time, when something happens to us, it is because we aren't paying attention," he says. "You should always be on your toes. If you are going from one place to another, carry yourself with a sense of confidence, even if you don't know where you're going." Your eyes are your first line of defence. Keep your head up and look straight ahead, regularly scanning the area from side to side. Recognizing a situation in front of you will give you more time and more options to avoid trouble. Additionally, look inside elevators, and other enclosed areas care-fully before venturing inside. Be sure to wear functional clothes. Avoid sling purses draped across the front because an offender can use the purse to pull you down or forward.

Avoid confrontation Using the high-powered Bruce Lee

kicks that you learned in karate class is, in fact, the last thing that you want to do. Safety experts recommend that you take preventive measures to avoid a confrontation completely- (only use physical confrontation as a backup to your psychological ability to get out of a situation.) So if that means crossing the street to avoid a situation, do it. If it means bowing out of an argument with an aggressive friend or stranger, do it. If it means handing over your purse to a robber, do it-and flee. Contrary to popular belief, self-defence is not about fighting; it's about doing what you have to do to save your life.

Don't surrender

If an offender wants your valuables, give them up, warns Officer Ron Rufo of the I Chicago Police Department's preventive programs division. Experts also advise you to avoid going into an alley, car, or abandoned building with the offender; do whatever it takes to flee. The [non-violent] offender doesn't want to be noticed; he wants to get in and get out of there," Officer Rufo explains. "Therefore, if an offender grabs your purse and wants to pull you into an alley, his intentions are not good. He wants to sexually abuse, severely beat or maybe even kill you. Always get away because the longer you are with the offender, the more likely you will be able to identify him in a line-up, and he knows this.

Use verbal enforcement

Forget what your debutante aunt told you about making a scene in public. You are fighting for your life, and the noise you make can save your life! Self-defence instructor Carrie Rentschler notes the "key to fighting back lies in the transformation of fear into anger and relax and use adrenaline to demand that an attack stop...using your voice transforms fear into anger by pushing energy out at the attacker." One of the first lessons that women are taught in rape-prevention seminars is to yell out a loud, shrilling NO! to the potential assailant. Not only will you catch the attacker off guard, but you'll more than likely get the attention of other people in the area. Never hesitate to attract attention if you are in trouble.

Don't let your guard down

Don't assume that all offenders are men in ski masks, warns officer Rufo, who points out that some are welldressed and others are women, who are partial to snatching your handbags. "There was a well-dressed thief who wore a mink stole," he recalls. "She walked around with an air of authority and when she entered someone's office space, no one questioned who she was. She went from floor to floor of this office building stealing purses." At your workplace, watch for those who loiter around the revolving door, Rufo advises.

One of the most dangerous mistakes women make is to let their guard down once they've reached their car. Granted, most women feel safe once they've reached their haven on wheels after darting across a dimly lit parking lot, but experts warn that there are some major safety precautions women should take before breathing easy. First of all, when you are walking toward your car, have your keys ready and placed in-between your fingers on your dominant hand. Not only will you be ready for a quick entrance into your vehicle, but just in case an assailant accosts you, you can use your keys as a weapon, says Officer Rufo, who gives a few other car safety tips. "We recommend that you: 1) put your packages in the bunk; 2) get into the car and secure your child, and 3) lock all doors immediately and pull away. If someone wants your car, give it to them." But then you must flip the script if a child is involved, he says, adding: "You must become the aggressor and say, 'You can have this car, but give me my child!' A thief doesn't want to be a kidnapper as well, because it would be worse for him [when he's appre-

To avoid a carjacking, have your doors locked and windows rolled up nearly all the way when you're driving. Whenever you come to a stop, allow yourself enough space between your car and the one in front of you, in case you have to manoeuvre at a second's notice.

places

Self-protection advocates recommend that first dates be spent in public, well-trafficked areas, and, if possible, you should take a friend along. (Spending a first date in a dark movie theatre or in a secluded area is not advised.) Pay attention to the red flags; if someone tries to get you to drink against your will, know that they do not have your best interests at heart. Look into your date's eyes and trust your gut feeling about him. Be wary of someone who is too "touchy-feely" on your date; if he makes unrecorded advances, cut the date short immediately.

Don't be a creature habit.

You get up at 5:30 a.m., go for your morning jog, come home, shower, and dress for work and stop by

The neighbourhood bagel shop on your way to the office. Sound familiar? Unbeknownst to many, habits are dangerous, because criminals, statistically, are more likely to have memorized your patterns of behaviour. The burglar knows when your home is empty. The sex offender knows when you leave the house alone. Officer Rufo warns women to change their routes if they work out daily, and if possible, to take a friend

Hampton agrees. "Vary every-thing that you do. If someone wants to do something to you, they will pay attention to your habits," he says. " And if you do work out, the time of day is important. It's much better to work out in the morning when the sun comes up than it is to run, ride or walk in the park after

When you are out of town, the safety rules still apply. Be conscious of your surroundings to eliminate the offender's element of surprise.

Make a commitment to yourself. You are worthy of protection, but don't live in a shroud of paranoia. To some, it may appear that taking precautions and being paranoid are one and the same. But nothing could be further from the truth. In fact, paranoia can be paralysing. "If you're paranoid, you are stricken with fear, and fear doesn't allow you to be pre- pared to deal with threatening situations," says Hampton. Conversely, self-defence is about being aware, and being empowered, not being afraid. Make a commitment to value your well being enough to invest in it, which means learning all you can about protecting yourself and foiling the plots of those around us who are up to no good

Freer medal awarded to Islamic scholar, Oleg Grabar

leading U.S. museum has honoured a prominent scholar for his life's work of teaching and writing about Islamic art and architecture.

On April 5, 2001, the Freer Gallery of Art in Washington, D.C., bestowed on Professor Oleg Grabar the prestigious Charles Lang Freer medal in recognition of his enormous impact on American understanding of Islamic art," according to Freer Director, Milo C. Beach.

The Freer medal was created in 1956 to recognize scholars for distinguished contributions to the knowledge and understanding of Oriental civilizations, as reflected in By William Amin

art. Grabar is the third scholar of Islamic art to win the award, after Iranian art specialist, Roman Ghirshman in 1974 and Ernst Kuhnel in 1960. The Freer Gallery is part of the Smithsonian complex of national museums in Washington. Giuseppe Sinopoli, has died after suffering a massive heart attack during a performance at the Deutsche Oper in Berlin.

Sinopoli, who was 54, was on the rostrum conducting Verdi's Aida when he dropped his baton and collapsed in the third act.

He was rushed to hospital, but doctors were unable to resuscitate him and pronounced him dead early Saturday morning.

The music world reacted with shock.

Organisers of the Wagner Festival at Bayreuth .in Germany, where he was to conduct the Ring Cycle later this year, said they were "dejected and stunned".

They have just over three months to find a replacement for what is one of the most gruelling jobs in the opera world.

In Italy, Prime Minister Giuliano Amato as well as members of the government coalition and the opposition paid tribute to Sinopoli as a leading light of Italian culture and a significant representative of the international arts scene.

Brilliant career Giuseppe Sinopoli had worked at many of the world's major opera venues,

amongst them the Metropolitan Opera in New York, La Scala in Milan, the Paris Opera and the Royal Opera House in London.

Sinopoli was born in Venice in 1946, and studied music at the city's conservatory in the late 19605sand

summer courses in the German town of Darmstadt in 1968.

Seven years later, he was to found the Bruno Maderna ensemble, named after the Venetian conductor under whom he studied in Darmstadt.

It was after this that Sinopoli began in earnest his career as both a composer and conductor.

He was appointed chief conductor at Rome's St Cecilia National Academy

A year later he took up the same post at the city's Philharmonic Orches-

To ban the BBC!

In yesterday 's acount we read about developments in the Northern Nigeria during the civil war, and the position of foreign nations on the Nigerian crisis. Today we read about the workers' strike and the anti- tax riot in the old Western State. Also the Federal Government considers banning the BBC from Nigeria.

According to the report in the New

Books

ccording to the Head of State and Commander-in-Chief of the Nigerian Armed Force "The whole nation has to be put on a state of preparedness to face all eventualities because of foreign intervention and because of our experiences from abortive peace talks in Kampala, Niamey and Addis-Ababa. It is now quite clear that in 1969, we have to fight resolutely for peace".

In its editorial on the same day, titled "Sweat and toil ", the *New Nigerian* said: "As we enter the new year; we are carrying with us the most pressing problems of the old. For the war continues... The year 1968 was a difficult one. There is no reason to believe that 1969 will be less difficult".

Apart from the war itself, the New Year also inherited unprecedented wave of workers' strikes for improved salaries and other working conditions. In a tradition, which has become entrenched since 1968, various unions threatened and in many cases did down their tools. The roll call included such giants as the 40,000 strong Western State Chapter of the Nigeria Union of Teachers and the Post and Telecommunications Staff. Others were the Nigerian Railway Corporation and the Nigeria Nurses Association.

Faced with a perplexing war, the federal government which was the employer of these public sector workers was forced to bargain from a very weak position. Indeed, it was apparent that the period under review was not one in which the government could be expected to make generous concessions as demanded by the unions. This was the reason why some of the workers such as the federation of Senior Staff Unions of Statutory Corporations withdrew their strike threats immediately after it was made. However, the pervasiveness of the strike cannot be over emphasised as even members of the Ministry of Defence Civil Employees Union actually gave government a 21-day ultimatum as reported in the New Nigerian of January 15. This was despite the fact that this group represented workers essential for the task at hand.

After the war and the strikes, the next biggest headaches of 1969 were the anti-tax riots in the Western State. These riots, which were carried over from the previous year, showed no signs of abating. On New Year's Day alone, three people were killed in Abeokuta and 1,500 arrested. According to a *New Nigerian* report published on January 7, the probe panel into the anti-tax riots, which began sitting on January 6,

disclosed that thirty lives had been lost thus far. The Wild West indeed!

Faced with this deadly combination of war, strikes and riots. no economy "Could possibly boom. Nigeria's did not. The mass interregional movement of people disrupted trade while investments and commerce declined. Import and export volume, for example, fell by 12 per cent in 1968 and would fall even lower in 1969. According to a report in the New Nigerian of March 7, the Federal Government would have to spend £ 1,163 million on a four-year reconstruction programme to undo the damages of the civil war.

A growing economy was needed both for the prosecution of the war on a sustained basis and for rehabilitation and reconstruction of the liberated areas. For instance, the Administrator of the East Central State, Mr. Ukpabi Asika, was saddled with the task of resettling three million people.

In spite of difficulties outlined above the most pervasive issue was the raging war. The various attempts at a peaceful resolution mentioned by Gowon in his New Year broadcast had no effect. Even as early in the year as February 1, the New Nigerian reported that the rebels had carried out air raids in the Mid-Western and South-Eastern States. Four Nigerians were killed in one such raid eight miles from Benin which had been liberated in the previous year.

In order not to lose its gains, the federal side had to resort to preemptive air attacks. This led to the bombardment of Umuahia, the last rebel stronghold and an attack on Aba. According to the *New Nigerian* edition of February 11, two towns-Elali and Obum-were liberated as a result of that exercise. During the course of the-first six months of 1969, several more towns were liberated from the stranglehold of the rebels.

Added to the necessity of ensuring effective governance of the liberated areas, this task stretched the nation's resources to the limit. Yet, the feat was accomplished. For instance, an Executive Council for Rivers State comprising eight civilians and the Military Administrator were named. Ken Saro Wiwa was appointed member of the Executive Council with responsibility as Administrator of Bonny Province.

The greatest source of concern over the war were those from abroad, for, as the war dragged on, it became apparent that several countries

including Ivory Coast, Tanzania, Zambia and Dahomey in Africa as well as France, Britain and the US in the West were supporting the rebels in one way or another. This support was most insidious on the part of France and the US because it was persistently denied by the two governments. West Germany and the Scandinavian countries as well as the invidious Caritas -the so called Catholic Relief Organisation -interpreted the war on religious grounds.

On January 2, the New Nigerian reported, the US Ambassador to Nigeria, Albert Mathews, pledging the support of the diplomatic corps to the Federal Military Government against the rebels. But this was a message about which many Nigerians in and out of government were sceptical. On February" 1, the same

paper reported that Police Commissioner Alhaji Audu Bako, the Military Governor of Kano had said Nigeria was suspicious of the US involvement in the civil war. He was speaking in the aftermath of the controversy over the donation of eight master airplanes for transportation of relief materials to the rebel-held areas.

Over the months, there were persistent complaints from the Federal Government that the US and France as well as the Geneva based International Committee of the Red Cross (ICRC), the Vatican's Caritas and the Joint Church Aid were arming the rebels under the cover of

relief supplies and humanitarian missions. For example, a report culled from the London based Sunday Telegraph and published in the *New Nigerian* of February 10 said that the French alone were delivering 150 tons of arms to Ojukwu every week. These were routed through the French speaking West African countries especially Dahomey to which Nigeria protested over the use of its air space for illegal ICRC and other flights.

However, not all was lost on the international arena. Major world bodies such as the UN and OAU remained supportive of the federal cause. The UN Secretary General, U. Thant, maintained a personal representative in Nigeria for six months at a time while the OAU had a committee on the Nigerian crisis headed by Ethiopia's Emperor Haile Selassie. There was also the International Observers team, which visited various parts of the country including the crisis-free North where they inspected houses abandoned by the Igbos at the outbreak of the

The cumulative effect of all these was that most responsible members of the international community understood and identified with the cause of the federal government of keeping Nigeria together and united in spite of the skilful and effective anti Nigeria propaganda of the rebels. Apart from regular statements of support, these friendly nations ranging from the USSR to Kenya and from Egypt to Indonesia contributed in blocking the rebel's path to victory. One such classic move was when the rebel's envoys were barred from entering the UN building in New York by the Organisation.

To those who opposed it, the government was unequivocal. Representing General Gowon at the 28 nations Commonwealth meeting in London in January, Chief Obafemi Awolowo, the Vice Chairman of the Federal Executive Council told the world: "Nigeria is not accountable to any foreign country for the conduct of her internal affair's".

According to the report in the New Nigerian of January 7, the Federal Government had earlier on ensured that the Nigerian civil war was not an agenda for discussion at the meeting.

The New Nigerian had become completely disenchanted with Western nations and organisations especially the Commonwealth. In particular, the insincerity of Britain had become marked in its indefensible position over the unilateral declaration of independence by Ian Smith's minority government in Rhodesia as well as its racist immigration policy, In an editorial titled "A piece of diplomatic chicanery "published on January 11, the paper said "it would, be futile to put further pressure on Britain to do anything about Rhodesia". Before this, an editorial titled "The future of the Commonwealth" and published on January 4 had noted that "The world is becoming increasingly quizzical and the younger generation are too practical not to see through the gaps which form the old fraying threads of an incongruously woven fabric"

Similarly, when the then Federal Commissioner for Information Chief Anthony Enahoro disclosed that the Federal Government was considering banning the British Broadcasting Corporation (BBC) from Nigeria, the *New Nigerian* promptly followed the revelation with an editorial titled "Unwarranted hostility".

In the editorial published on January 14, the paper supported all forms of "punitive measures against the BBC". in retaliation for its meddlesomeness. The remarkable thing here was that despite the enormous need the government had to rally 'all round its cause, it did not take the machinations of such powerful enemies lightly.

There can be no complete analysis of the New Nigerian in this period without mentioning the famous "sex-in-a-car" scoop. This was a news story about how Andrew Obeya, the then Secretary to the Benue-Plateau State Government, was reportedly caught making love to a married woman in his car. The story which made the headline in the paper's February 1 edition was to become the subject of several court cases involving the Editor of the New Nigerian, Malam Adamu Ciroma, and Stephen Bamigbele his reporter on the one hand and Obeya on the other. With characteristic courage, the paper stood by its story even though it gave the accused ample opportunity to air his side.

He, however, assured that government would continue to provide consular assistance to Nigerian pilgrims. Onyia reminded members of the committee that one of the problems the government had always been faced with was "the predictable abscondment of Nigerian pilgrims in the holy land.

"Although the level of abscondment recorded during last year's pilgrimage was less than two per cent, I urge your committee to work harder for the total elimination of the ugly incidence of abscondment," he said.

Court orders lawyer's arrest

n Asaba Chief Magistrate Court presided over by Mr. Steve Okebu has issued a warrant of arrest for one Moses Oddiri, a Lagos lawyer, who allegedly escaped from lawful custody at the Ogwashi-Ukwu prisons on February 23 this year.

Okebu said he order is based on the combined provisions of Sections 143, 281(1) and 351 of the criminal procedure laws of Bendel state, also applicable in Delta.

He also ordered the Delta state commissioner of police to carry out a comprehensive investigation into the manner and circumstances surrounding the incident, saying that the police should report back to the court within 14 days.

In making the ruling, the Chief Magistrate said that any prison staff involved in the escape or surreptitious smuggling out of the suspect, should be arrested arraigned for frustrating the course of justice.

He also ordered the comptroller of the Federal prisons Ogwashi-Uku to be present in court on May 15 to listen to the findings of the court.

Okebu's ruling followed an application made by Senior State Counsel, Marcel Okoj asking for an inquiry to unravel the mystery surrounding Oddiri's escape from lawful custody and for an order on the comptroller of prisons to produce Oddiri at the next hearing, while prisons staff involved be punished.

Okebu in the ruling, however, discountenanced arguments by Oddiri counsel, I.S. Ujobo, that the court should adjourn the mater indefinitely, because of an appeal coming up before the Court of Appeal in Benin.

The magistrate said that the Court of Appeal did not order a stay of proceedings. saying that it had jurisdiction over the matter based on the ruling of Asaba High Court, which overturned the ruling of a Lagos High Court granting Oddiri bail.

Farmers association seeks clarification on deregulation

he National Farmers Association under the auspices of National Agricultural Coordinating Committee yesterday, stormed the National press center in their thousands seeking clarification on what the government meant by deregulation.

In his address at the occasion, the chairman of the association, Alhaji Abubakar Wodi, said the Farmers' mission was to "receive the briefing fresh from the original source.'

He said the grassroots farmers, which he claimed make up about 75% of the total population of the nation were left out in the process towards deregulation.

According to him, it was because of "out size and significance in the economic sector that we have decided to request you to grant us the briefing session." This, he said, would make the farmers partake in the decisionmaking process on the road to deregulation.

The chairman who blamed the woes of Agriculture in recent times on military incursion into politics, said the sector is basically suffering from neglect. Furthermore, he listed three factors which had

down among others. In his answers, Prof Gana praised the level of mobilization of the farmers, describing it as worthy of emulation. He said the federal government was determined to give every support necessary to farmers to help them produce adequate food for the population.

Deregulation, the minister said, "simply means opening the market for more people to come in, to remove the monopoly of the NNPC. It is just a kind of market liberalization so that other people can participate," he said.

For this to work, according Prof Gana, government cannot sit in the office and fix prices for petroleum products but would allow market forces to work out the price.

"It is likely that prices might slightly increase but as more companies compete, the prices will normalize. This will lead to rise in some places and fall in some others," the minister emphasized.

Noticing that government regulated prices for petroleum products had always been flaunted, Prof. Gana allayed the fear of the people that prices might not be reasonable. He said a regulatory agency made up of Stakeholders, like Nigerian Labour Congress, farmers, journalist, private sector, e.t.c. will be establish to monitor the activities of the independent refineries and suppliers.

On the fear that transport fares would be hiked, the minister said that government was working towards bringing in new efficient cars and buses which consume less fuel. He also said the railway was being revived to provide the required alternative to road transport.

The Minister thanked the farmers for seeking clarification from his office and urged them to support deregulation as this was the only way of making them king in the petroleum distribution network.

Brazil's reputation as world beaters is in tatters after a series of dismal performances and results in the South American World Cup qualifying group, culminat-ing in last month's stunning 1-0 defeat in Ecuador.

Coach Emerson Leao, who has made sweeping changes with former world player of the year, Rivaldo among the casualties, knows that the knives will be out should his team fail again.

The game will be played in Sao Paulo's Morumbi stadium and it's notoriously fickle crowd, which threw Brazilian flags onto the pitch in protest during Brazil's last match at the venue - even though they beat Colombia 1-

Brazil have slumped to third in the group with 20 points from 11 games, only one ahead of Ecuador and two ahead of Colombia. Meanwhile, they are eight points behind leaders Argengina and three adrift of Paraguay

Only the top four teams qualify automatically for Japan and South Korea next

> Leao, who took over only six months ago, has included seven uncapped players in his squad and only three of the country's foreign-based stars.

Oliseh, Okocha abandon Eagles

he thick gloom hovering over Nigeria's World Cup 2002 qualification quest was compounded yesterday with five key members of the Super Eagles, signaling their intention to discontinue participating in the remaining matches.

Leading the five is skipper Sunday Oliseh of Borussia Dortmund Germany, Derby County's sweeper, Taribo West, Real Malloca's Finidi George, Arsenal Kanu Nwankwo and PSG's Austin Okocha. They cited crowded club schedule as the main reason for opting out of the three remaining matches.

Skipper Oliseh, whose leadership of the Eagles has yielded nothing but failure, said he would abandon ship mid-stream because he doesn't think there was still any chance of Nigeria's qualification noting that it was however, not impossible for the country to scale through to the Japan/Korea World Cup 2002.

The five players who would not show any remorse for their individual and collective roles in Nigeria's failure to secure the 2002 World Cup qualification with relative ease, said the hope of qualifica-

tion was rather dim with Saturday's 0-1 lost to the Leone Stars in Freetown, Sierra Leone.

Meanwhile, Johannes Bonfrere, the Eagles technical adviser, who had earlier vowed to throw in the towel should the Eagles fail to beat the Leone Stars have reneged on this words.

Bonfrere said on arrival from Freetown, Sierra Leone that he would not resign because the players have pleaded with him to stay with the team and to serve out his contract. The contract which expires in 2002 was predicated on Nigeria's qualification for the Japan/ Korea World Cup.

Bonfrere, who had earlier challenged Tijjani Yusuf, the NFA scribe, to stake his job if the Eagles beat their counterparts last Saturday, vehemently denied ever staking his resignation on the outcome of the match against Sierra Leone.

The Dutchman would not be bothered about the

emergency meeting of the board of NFA, scheduled to hold on Thursday. Bonfrere said he would rather be concerned with the May 5 cracker against Liberia scheduled for Port Harcourt than worry about whatever outcome of the emergency meeting.

The board has scheduled a crucial meeting in Abuja where it is expected to assess Nigeria's chances for qualification, if any, and what needs to be done to facilitate the qualification.

Sports Ministry, National Assembly want Bonfrere sacked

The incessant calls for the termination of Johannes Bonfrere's contract took a new dimension yesterday as both the National Assembly and the Sports Ministry threw their weights behind the call.

Sports Minister, Ishaya Mark Aku said the ministry was overwhelmed by the clarion calls for the sacking of the Super Eagles technical adviser, and would not hesitate to ratify whatever decision the board of the Nigerian Football Association (NFA) decides on Thursday.

Aku said Banfrere's continued stay in Nigeria

has given everyone enormous concern over the future of Nigerian football, noting that the termination of Bonfrere's contract would save Nigeria from further plunge to oblivion.

Similarly, the vice-chairman of the Senate Sports Committee, Senator Abubakar Sodangi said the National Assembly would be behind any action taken by the NFA to redeem Nigeria from further disgrace in football.

Sen. Sodangi said, "the Senate was disturbed that minnows are rubbishing Nigeria in football simply because of the incompetence of a so-called technical adviser who has been unable to harness the abundant talent in the country to give us a credible Super Eagles."

According to him, "the entire National Assembly is disturbed and very worried that in spite of available talents, the Dutchman has not been able to groom and blend them for effective results hence, would support any action taken to rid the country of Bonfrere."

He assured that the National Assembly would facilitate the payment of 180,000 dollars, said to be due to Bonfrere in the event of the termination of his contract.
