

# A BILL FOR

A LAW TO AUTHORISE THE ISSUE OUT OF THE CONSOLIDATED REVENUE FUND OF THE GOVERNMENT OF DELTA STATE OF THE SUM OF TWO HUNDRED AND THIRTY FIVE BILLION, FIVE HUNDRED AND EIGHT MILLION, THREE HUNDRED AND FORTY THOUSAND, ONE HUNDRED AND ONE NAIRA AS RECURRENT EXPENDITURE AND THE SUM OF THREE HUNDRED AND THIRTY SIX BILLION, ONE HUNDRED AND TWENTY EIGHT MILLION, FIVE HUNDRED AND SEVENTY THOUSAND, EIGHT HUNDRED AND NINETY NAIRA AS CAPITAL EXPENDITURE FOR THE SERVICES OF THE YEAR ENDING ON THE THIRTY-FIRST DAY OF DECEMBER, 2023 AND TO APPROPRIATE SAME FOR THE PURPOSES SPECIFIED IN THIS LAW.

BE IT ENACTED by the Delta State House of Assembly as follows:

1. This Law may be cited as the Appropriation Law, 2023 and shall be deemed to have come into force on the 1st day of January, 2023.
2. The sum of Two Hundred and Thirty Five Billion, Five Hundred and Eight Million, Three Hundred and Forty Thousand, One Hundred And One Naira shall be appropriated from the Consolidated Revenue Fund of the State as Recurrent Expenditure during the year ending on the 31st day of December, 2023 for the services set out in the First Schedule to this Law.

3. The sum of Three Hundred And Thirty Six Billion, One Hundred And Twenty Eight Million, Five Hundred And Seventy Thousand, Eight Hundred And Ninety Naira shall be appropriated from the Consolidated Revenue Fund of the State as Capital Expenditure during the year ending on the 31st day of December, 2023 as set out in the Second Schedule to this Law.




